Engaging the Student as Citizen: Teaching the Political Communication Course in a Presidential Campaign Season (Short Course #5)

Presenters: Craig A. Smith, Trevor Parry-Giles, and Mitchell S. McKinney

Description: A presidential election season provides an ideal teaching laboratory to engage students as active citizens in the civic process. During this period, many instructors may teach a course in political campaign communication, or include activities surrounding the ongoing presidential campaign as part of other communication courses. Led by "seasoned" political communication faculty, this short course will examine different approaches to developing a political campaign communication course. Participants will be provided with a number of campaign instructional resources, course syllabi and assignments, and activities for engaging their students – and citizens– in the "real world" of a presidential campaign.
