"Communicating the Possible"

The Rhetoric Theory and Criticism Interest Group invites submissions of papers and panel proposals for the 2013 CSCA Conference to be held in Kansas City. We welcome topics related to the advancement of rhetorical theory and criticism. In conjunction with the convention theme, we encourage submissions that engage in ideas that extend the boundaries of rhetoric and explore the potential of rhetorical communication in a variety of situations. We invite scholars to consider subjects that include, but are not limited to the following: Presidential rhetoric and the visionary power of public discourse; contemporary engagements in body and performative rhetorics; rhetoric and pedagogical practices; critical rhetorics that examine racial and sexual diversity; rhetorics of place and space; sports rhetoric; organizational rhetoric; health rhetoric; food rhetoric; rhetorical constructions of technology, science, and new media; visual and material rhetorics.

Additionally, we request undergraduate and graduate students to submit their papers. We also accept a variety of formats including competitive papers, panels, roundtable discussions, debates, and seminars. These alternative delivery formats provide a more interactive engagement with audience members.

**Awards:** The Rhetorical Theory and Criticism Interest group presents two awards. The Karlyn Kohrs Campbell Award is presented to the author(s) of the top paper. The David Zarefsky Award is presented to the author(s) of the top student paper. Each award winner will receive a certificate and monetary prize.

#### **GUIDELINES FOR SUBMISSION:**

All submissions must follow the guidelines to be considered.

- Papers—Only completed papers will be accepted. Please include a detachable title page that allows the author's identity to be concealed. Papers should not exceed 25 pages, excluding references. Additionally, all papers should contain a 50-75 word abstract. Remove all author references in the text of the paper. Indicate if author(s) is/are Central States Communication Association members. Students should mark their papers as "Student Paper" in the upper right hand corner of the title page. Student papers are those who are authored only by the students. Faculty mentor/advisors should not appear as an author of student submissions.
- **Panel Proposals**—Individuals proposing panels must complete the 2013 CSCA Panel Proposal Request Form (available at <a href="http://www.csca-net.org">http://www.csca-net.org</a>). Panel submissions must include (a) a title; (b) a brief abstract of the panel; (c) name of the person responsible for the program; (d) names, institutional affiliations, and contact information (address, email, and telephone) of each panel participant; (e) title and abstract for each individual work. Indicate if participants are CSCA members.
