## Spivak to Keynote 2006 Convention in Philadelphia

Gayatri Chakravorty Spivak, Avalon Foundation Professor in the Humanities at Columbia University, will be the keynote speaker at ECA's 2006 convention in Philadelphia. Dr. Spivak is a literary theorist who helped define the field of postcolonial studies. In *Can the Subaltern Speak?*, Dr. Spivak addressed Western intellectuals' ability to mediate the historical experience of the working classes and has further addressed this issue in more recent publications.



Among Dr. Spivak's publications are *In Other Worlds*, *The Post-Colonial Critic*, and *Outside in the Teaching Machine*. She was born in India and earned her B.A. at the University of Calcutta. Dr. Spivak earned her Ph.D. at Cornell University in 1967 and has taught at universities in the United States, India, Canada, Saudi Arabia and Germany. Among other achievements, she has been a Guggenheim Fellow, holder of the Tagore Fellowship at the Maharaja Sayajirao University of Baroda (India), a Fellow of the National Humanities Institute, a Fellow of the Center for the Study of Social Sciences (Calcutta) and a fellow of the Davis Center for Historical Studies (Princeton).

## ECA to Place All Its Journals and Archives Online

In August of this year, ECA successfully completed its year-long negotiations with EBSCO Publishing, Inc. The final agreement will place all of the back issues of all of ECA's journals and ECA's archive online. This agreement means that within the year all of the past issues of all of ECA's journals will be available to the public online. By placing ECA past journal issues on the

Internet, millions of people—literally—will potentially have access to the scholarship of the Association.

In addition, ECA's archive has not been readily available to its members and to others who might find the archive useful for historical scholarly endeavors. For the last few years, the ECA archive has been housed at the University of Utah. While the arrangement with the University of Utah preserved the archive, the cost has seemed excessive, particularly when one considers that few people have received any direct benefits from the service. Beyond placing all of ECA's archive online, EBSCO will also create a new online document, *ECA Past Presidents*, that will make the papers and documents of each of its past presidents available to all online.

The final agreement was a particularly beneficial agreement for ECA in terms of the funds it will generate. EBSCO will pay ECA \$17,400 annually for the right to disseminate the contents of all of ECA's journals and archives through various electronic and optional media including the Internet and through online hosts.

ECA has granted EBSCO exclusive rights to its back issues and archive. Granting EBSCO exclusive rights allowed ECA to increase its minimum guarantee fee from \$12,000 to \$17,400. The funds ECA receives under this new EBSCO agreement exceed all of ECA's income from all other agencies under all of its various license agreements.

The outcome was the result of a cooperative effort among all of the various units of ECA. The ECA officers encouraged me to explore various options and possibilities with EBSCO. The ECA Executive Council granted me the right to negotiate on behalf of the Association. Danette Johnson did all of the background checks to be sure we knew what we could and could not do in terms of ECA's existing contracts. And, Susan Drucker, ECA's legal representative, clarified previous licensing agreements and renegotiated other agreements so that the exclusive agreement with EBSCO could be legally signed.

### ECA Member News

ECA member **Richard A. Katula** has received a Fulbright Foundation Senior Specialist Scholarship for the country of Greece and will deliver a series of lectures there on American politics and Greek-American relations.

**Richard A. Katula** and **Sandra Stotsky** have received a \$75,000 grant from the Filene Foundation to sponsor a We the People summer institute for urban high school teachers. The institute will focus on primary readings and discussion of the founding documents of our nation: The Declaration of Independence, the Constitution, the Bill of Rights and the Federalist Papers.

## First Vice President Elect-Select Candidate Statement: Jeffrey Pierson

When I began my academic journey at North Carolina State University (BA '86) it was to study forestry. However, after I arrived I soon found myself passionate about the study of communication. During the fall of my senior year, I attended my first academic convention (NCA) and decided to attend graduate school. I went on to study at Temple (MA '88) and Rutgers (Ph.D. '94).

In 1992, I was hired at Bridgewater College in their English Department to direct their newly created communication minor, coach a debate team, and teach an occasional English Composition section- such is life at a small, private, liberal arts college. In 2000, through steady persistence, we added a major, and I became the founding chair of the new department of communication studies, which now employs seven full time department members. In addition to leading the development of a new major/department, I have been involved in several activities that have made me, I believe, uniquely qualified to plan and organize ECA's annual convention.

From 1997-2003, I directed the Bridgewater College Leadership Institute and the High School Leadership Academy. This summer program involved hiring a staff of 30 college students and organizing events for over 100 high school students. I also led the planning of yearly student leader retreats and excursions. From 1992-2000, I coached an intercollegiate debate and forensics team and have hosted several tournaments on our campus for both colleges and area high schools. I was also the founding advisor for the Mass Communication Organization, Lambda Pi Eta Chapter, Alpha Phi Omega Chapter, and the Pi Kappa Delta Chapter. I also have served as an advisor for the Bridgewater chapters of ODK and Alpha Chi, and I advised the college yearbook, from 1997-2000.

Recently, my college president asked me to direct our arts and lectures series. Last academic year, I organized about 90 of these programs. This consisted of providing leadership for all aspects of the series, such as arranging

As for ECA service, I have been an interest group planner three times for the Argumentation and Forensics Interest Group and twice for the Theory and Methodology Interest Group. I have also served one term as the Executive Council representative from the Theory and Methodology Interest Group, and I was just elected in Pittsburgh to serve again.

I am the author or co-author of many conference papers and a few publications. I am most proud of being a co-author of *Integrating HIV/AIDS Education into Communication Courses: A Manual*, (1997) published by NCA. I have served on the editorial board of Speaker and Gavel.

If elected, I will work to maintain the excellent quality of our three journals; attempt to improve the organization and structure of our conference; and, most importantly, I will work to control the costs associated with ECA membership and attending our convention.

### Everett Lee Hunt Award

The Everett Lee Hunt Award is presented annually at the discretion of the ECA Committee of Scholars. The Hunt Award reflects the philosophic commitment

and scholarly contributions of Everett Lee Hunt, one of the founders of the discipline of communication and the eighth president of ECA (1927-1929).

The nominee should have provided a major contribution to the understanding of rhetoric and communication as a human function in the contemporary world; a means of explaining and realizing public responsibilities beyond the discipline of communication; and/or an intellectual and humane instrument for merging diverse fields of knowledge in a way that infuses them with moral purpose and public significance.

The guidelines for the Hunt Award include: (1) the nominee must be a member of ECA at the time of nomination; (2) the nominee's published work (e.g., an article, book, position paper or monograph) must be dated in the previous calendar year; (3) nominations must be for scholarly (including creative) work. ## Journal of Intercultural Communication Research

The editor is soliciting manuscripts for the *Journal of Intercultural Communication Research*, a publication of the World Communication Association. JICR publishes qualitative and quantitative research that focuses on interrelationships between communication and culture. Submitted manuscripts may report results from cross-cultural comparative research or from other types of research concerning the ways culture affects human symbolic activities. Studies reporting data from within a single nation/culture should focus on cultural factors and explore the theoretical or practical relevance of their findings from a cross-cultural perspective.

Manuscripts should be no more than 25 pages long, not including tables and references, and must conform to the stylistic guidelines of the Publication Manual of the American Psychological Association (5<sup>th</sup> Ed.). Papers may be submitted via hard copy or electronic attachment. Hard copy submissions must include three copies of the paper. Electronic submissions must be sent as an email attachment in Word or WordPerfect. For all submissions, the manuscript's cover page must include a title, author name(s), mailing address, email address, phone number, and fax number. Author identification should include the author's current affiliation and highest earned degree (including the institution granting the degree and year granted). A 100 word abstract must follow the title page.

Manuscripts deemed appropriate for JICR and that conform to the above guidelines will be subjected to blind review. Manuscripts that do not conform with the mission of JICR or the above guidelines will not be reviewed.

## Proposed Bylaws Changes

ECA's Task Force on the Nominating Committee has been working over the past two years to evaluate the current nomination process for First Vice President Elect, NCA Legislative Assembly Representative and NCA Nominating Committee Representative. Two important issues that the group considered in its discussions were maintaining active representation and participation of the interest groups while also providing the Nominating Committee with complete information about each candidate.

As a result of the Task Force's discussions and input from the Executive Council, two substantive changes to the present system are proposed. First, the Immediate Past President of ECA would serve as chair of the Nominating Committee. This is proposed to have a definite person responsible for convening the Nominating Committee and getting the committee started on its work. Additionally, the Immediate Past President knows a large number of people in the organization and can assist in recruiting qualified candidates for the nominations slate. The other substantive change is that the Nominating Committee will begin meeting one year before it submits its nominees to the membership (i.e., the Nominating Committee that meets at the end of the 2006 convention would work through 2006 and present its nominees to the membership in April, 2007 to be voted on in Fall, 2007). This change is proposed so that the Committee has additional time to discuss potential nominees and obtain more information about the nominees and their institutional support.

Any changes to the ECA bylaws must be submitted to the membership for mail vote. Bylaw amendments are adopted if approved by a majority of the members voting (ECA Bylaws, Article XIV). The text of the proposed changes is below. Voting on these changes will occur as part of the ECA Fall election ballot that will be appearing in your

mailbox soon. Please take the time to read the proposed changes and vote.

## Proposed Changes to ECA By-Laws

### [Article V, Sections 1, 2, 3, 4, 5, 6 and 7].

[Strikethroughs means deleting the original language and italics mean new language has been inserted or the original language was moved to a new section.]

Section 1. The Nominating Committee shall prepare annually a slate consisting of at least two nominees for the office of First Vice President Elect, at least two nominees for each open position on the National Communication Association Legislative Council Assembly, and at least two nominees for the National Communication Association Nominating Committee. ~~The Nominating Committee shall meet formally prior to and/or during the annual convention and report their nominees to the membership at the general session. Additional nominees for any office may be added by a majority vote of members attending the general session.~~

Section 2. The Nominating Committee shall be composed of representatives of all recognized Interest Groups. The Interest Group representatives will be the Chairperson of that group or such person as the Interest Group shall delegate. ~~The chairperson of the Nominating Committee shall be designated from among the committee members by the President of the Association. The Immediate Past President will serve as the Chairperson of the Nominating Committee.~~

Section 3. *The Nominating Committee will meet following the general session and before the end of the convention to begin deliberations for selection of the slate of candidates to present at the following convention. The Nominating Committee will report their slate of nominees to the membership at the following convention's general session. Additional nominees for any*

*office may be added by a majority vote of members attending that general session.*

Section 3 4. In the Fall at the beginning of the academic year, a full membership secure ballot listing of all nominees for each office shall be distributed by the Executive Director. Should no candidate for First Vice President Elect receive a majority of votes cast, a runoff election will be held between the two candidates receiving the largest number of votes shall be elected.

Section 4 5. Nominated by the First Vice President, the Second Vice President shall be appointed by the Executive Council and serve for a term of one year. The Executive Director and Editors of scholarly journals shall be appointed by the Executive Council and serve for a term of three years.

Nominated by the First Vice President, the Convention Advertising Manager shall be appointed by the Executive Council and serve for a term of one year.

Section 5 6. Elected association officers shall assume office at the conclusion of the general business meeting at the convention immediately following their election. The

Second Vice President shall assume office at the conclusion of the general business meeting at the convention immediately following their appointment. The Executive Director shall assume office on July 1 of the year in which the term of his or her predecessor concludes on June 30. The Editors of scholarly journals shall assume office, January 1, immediately following the calendar year in which the term of his or her predecessor concludes on December 31. Section 6 7. To be entitled to vote in Interest Group elections, an individual must have been officially affiliated with the Interest Group on December 31 of the year immediately preceding the election. The Executive Director shall provide the Interest Group Chairperson a list of individuals so eligible prior to the business meeting of the Interest Group. The quorum for each Interest Group's business meeting shall be established by the Interest Group itself in its Bylaws.

The 2006 convention, with its theme **Transforming Communication and Community**, is designed to address the changing nature of our everyday lives as well as the ongoing process of developing disciplinary discourses that have transformative potential for lived communities. "Transforming" in this case refers to both an adjective and verb. As an adjective, "transforming communication" and "transforming community" are the kinds of discourses and communities that are dynamic and actively adjust with changing conditions. For example, with the expansion of new media we inevitably consume and share information differently and this has affected both the way we communicate and the way we define ourselves. Even as we reflect on the 2004 presidential election, we can see how the various contours of the campaigns accented disproportions in healthcare, morality, crime, terror and unemployment all within the confines of the candidates' promises of transformation and hope.

As a verb, "transforming communication and community" suggests we all are potentially change agents at any given moment in the stream of intellectual exchanges occurring within the varying contexts where we express our ideas; hence, this is a call to consider the ways in which we might rethink the character, condition and function of our field and its relationship to non-academic communities. The verb signifies that we must ask how and for whom we exist. We are in a unique position to enhance people's lives because we know as much, if not more, about the process and nature of communication as a reflexive, instinctive, facilitative and transformative act than anyone else in the world. We have the ability to facilitate community capacity building. The 2006 convention theme invites dialogue about how we might best heighten communication inquiry academically and in everyday practice. Although the theme is fairly simple, it encompasses an entire new world of discovery and potential. So, I welcome you to attend, present and participate in the various planned panels, activities and events at the 97<sup>th</sup> annual ECA convention in Philadelphia, PA.
