PAST- Investigation of the Past NCDA Location Trends

Project Description:

Due to the high attendance rate of the Atlanta Georgia NCDA 2012 Conference (largest attendance in the history of NCDA), I analyzed the past four NCDA Conferences and surveyed current NCDA members investigating the possible correlation between attendance rates and conference locations.

Summary/Conclusion:

Survey: All 352 respondents were current NCDA members from all across the world and opinions varied from never attending a conference before to being a regular/frequent attendee. There were ten questions in total with a combination of multiple choice and text box choices. Below lists the summary of survey findings with rating averages.

The past data conference quick counts (which are listed above) are consistent with my survey findings in terms the most influential factor when considering attending an upcoming NCDA conference, cost is the largest factor in determining commitment to attend or not. This leads me to conclude that the lowest cost for an attendee is when the conference is located in or near the attendees' state of residence. For example, the NCDA 2009 Global Conference was located in Missouri and the top two attendee states are Illinois (70) and Missouri (69).

Results/Recommendations:

Through investigating the past four conferences as well as surveying current NCDA members, I determined overall that conference location is a factor when choosing to attend a conference, however the overarching opinion is that conference cost is the largest determining factor when attending NCDA conferences. Results also brought up some positives about past conference locations, 91.9% of survey participants indicated that past conference locations either exceeded or met expectations, 89.2% of survey participants indicated being satisfied with past hotel accommodations, and 56.4% of survey participants are more likely to attend a conference in June or July which is consistent with NCDA Annual conference past dates. *"Thanks for your hard work", "Your group has done a great job delivering a quality conference experience", and "I have only good things to say about my conference experiences and I am looking forward to Boston!"* are just some of the positive comments collected in this survey. Therefore, overall I conclude that throughout the years NCDA has established a positive reputation within the career counseling community and takes NCDA members into consideration when planning for upcoming conferences.

My recommendation is to continue to rotate conference location from east, west, and middle regions, however I encourage conference committee planners to look into lower cost hotels as an option for future conferences as well as factoring in safety as a consideration when choosing the next venue.
