MESSAGE FROM THE PRESIDENT

A word from OACDL President-Elect and Seminar Co-Chair Tim Huey - about the focus of the seminar, the speakers and what you will get from this seminar.

The focus of this seminar

I wanted a seminar applicable to all criminal defense lawyers and that would have immediate benefit for every attendee –even those not so geared to criminal defense. I chose persuasion as the theme. Whether we are trying to persuade folks surfing the net (or search engine robots) to find us and call us or persuade a prosecutor to see things our way or persuade a judge to rule our way (or just get out of the way) or persuade a jury to render two word verdict - persuasion is key to everything we do. I have been fortunate to know and learn from many folks who are masters of some aspect of the art of persuasion that is critical to us as lawyers. While I am the least important speaker at this seminar, I will do a short presentation of the highlights of "What I have learned from the Masters."

The Superstars who have agreed to Share Their Wisdom and Tactics with Us

I am honored and humbled that the folks on my "wish list" have agreed to come and share their knowledge with us. With each of these speakers I always learn something and always am inspired to try something new. Below I will tell you a little about each of them and what they will share with us.

Pushing the Not Guilty Button in Jurors Brains – Making Jurors Want to Render a Not Guilty Verdict ~ Superstar Patrick T. Barone Esq. of Birmingham, Michigan

Pat is the author of several books and many articles including a monthly column for Michigan's Criminal Defense Newsletter and serves on the faculty of the Criminal Defense Attorney's of Michigan Trial Practice College. Most importantly, for us, Pat is a graduate of Jerry Spence's Trial Lawyer's College and has spent a great deal of time, with the help of Paul Homoly, trying to figure out how to talk to jurors in a way that "changes their frames" and motivates them to vote Not Guilty. Pat's presentation will make you rethink how you approach your next trial.

What lawyers need to know about internet marketing – what you need to talk to your IT & SEO people about ~ Superstar Vanessa Fox of Seattle Washington

Vanessa has been called a "cyperspace visionary." She is not a lawyer but Superstar on internet marketing arena. She has traveled the globe discussing the evolution of how we search for and consume information. She created Google's Webmaster Central, to help website owners improve their sites and get more customers via organic search and was instrumental in the sitemaps.org alliance of Google, Yahoo, and Microsoft Life Search. Her book "Marketing in the Age of Google" is considered the Bible for internet marketing. As impressive as her accomplishments are, the reason I begged Vanessa to come speak to us is that she can explain this stuff in a way that even I can understand.

Innovative Tactics for Trials and Motion Hearings – The Art of Creative Combat ~ Superstar Bruce Kapsack Esq. of San Francisco and Oakland California

Bruce is a close friend and I have probably heard him do 30 or more presentations —and yet I wouldn't miss this one for the world. Bruce is a wildly popular and sought after speaker nationally. When it comes to tying cases, Bruce is the real deal and because of this he is regularly asked to be the defense lawyer in the Mock Trial at the National College for DUI Defense, Masters of Scientific Evidence seminar. Bruce is known for not backing down and yet somehow managing to keep the jury on his side and (mostly) stay out jail - even when he has to stand up against bullies in black robes. He will share his secrets with us in his presentation and entertain us as he does so.

Using Technology to Make your Point - Avoiding Death by PowerPoint ~ Superstar Justin McShane Esq. of Harrisburg Pennsylvania

Justin is a trial attorney who specializes in using forensic science in defending citizens accused of crimes. A fellow with the American Institute of Chemists and a Senior Assistant Chromatography Instructor with the American Chemical Society, you'd think he would be boring and fond of dry and dull PowerPoint presentations. You don't know Justin. Acutely aware of how quickly you can lose a jury or an audience when trying to present complicated material, Justin has put a lot of time, effort and study into how to effectively use technology to enhance, not detract, from a presentation. With new courtrooms and technology everywhere we would be wise to pay attention to Justin.

The Main Event- Learning the Art of Jury Persuasion from a True Master ~ Superstar and Cowboy Lawyer Extraordinaire Gary Trichter Esq. of Houston & Bandera, Texas

Gary is just plain masterful at talking to juries and grafting into their subconscious -and even into their souls- the ideals of presumption of innocence and proof beyond a reasonable doubt. By simply talking plainly to jurors and through carefully framing the questions, Gary can take a group of folks who walk in ready to embrace the prosecution and its witnesses and turn them into cadre who are pro-freedom, pro-individual, skeptical government and down right hostile to the prosecution. Once you hear Gary discuss how to do it you realize that it's not magic, nor something only he can do, but is something you too can learn to do. Gary is co-author of the two-volume treatise and is author of over forty journal articles ranging from DWI, grand jury, drug couriers to aviation. He is past chairman of NACDL's Drunk Driving Committee and past Dean of the National College for DUI Defense. A former Director and DWI co-chair for the Texas Criminal Defense Lawyers Association (TCDL.) Gary is currently the President of the TCDLA and I am so honored to have my friend and TCDLA President here to help me kickoff my presidency of the OACDL.
