ABOUT THE PRESENTERS:

D. Timothy Huey

Huey has been a criminal defense lawyer since obtaining his law degree in 1984. He now limits his practice almost exclusively to the defense of DUI cases. By participating in associations such as the National College of DUI Defense and the OACDL and NACDL, and specifically national and state seminars relevant to DUI litigation, he attempts to ensure his knowledge, training and expertise will meet standards similar to those areas of law that now permit lawyer specialization. Huey is a life member of OACDL, having served in many capacities and written numerous articles on DUI subjects. He was also nominated for lifetime membership in the National College as a Sustaining Member. He is now president of the OACDL.

Jon Saia

Saia has 25 years of experience in defending DUI cases. He also provides consultation and expert testimony on the issue of field sobriety testing and is often consulted by colleagues with regard to breath testing issues. The National Highway Traffic Safety Administration and the International Association of Chiefs of Police have certified Saia as an instructor in DUI Detection and Standardized Field Sobriety Testing. In addition, National Patent Analytical Systems, Inc. (the manufacturer of the BAC Datamaster) has certified him in the operation, diagnostic verification and calibration of the BAC Datamaster Breath Alcohol Testing Instrument, the most commonly used breath testing instrument in Ohio. Saia is a life member of OACDL and currently serves as CLE co-chair.

Andrew Bucher

Bucher is an associate attorney with Balyeat, Leahy, Daley & Miller, with offices in Lima and Toledo, Ohio. He has a Bachelor of Science in Pharmaceutical Science from the University of Toledo, College of Pharmacy and a Bachelor of Business Administration from the U.T. School of Business. Bucher received his J.D. from the U.T. College of Law. His undergraduate choices provide an extensive background in hard science, including pharmacokinetics (how drugs, including alcohol, are absorbed, distributed, metabolized and eliminated in the body), pharmacology, medicinal chemistry, biological chemistry and microbiology/immunology. Bucher is able to "speak the language" of the experts the state of Ohio brings. He is a member of OACDL and currently serves as CLE co-chair. He is also a member of NCDD (currently the only Northwest Ohio member).

Jessica Fallon

Fallon is an associate attorney with the Law Office of Saia & Piatt, Inc. with offices in Columbus and Delaware, Ohio and has dedicated her practice area to the defense of OVI charges and criminal and traffic offenses. She has completed training in the operation and maintenance of the Intoxilyzer 8000. She has also completed the National Highway Traffic Safety Administration's course on DWI Detection and Standardized Field Sobriety Testing - the same course administered to police officers throughout the state. DIRECTIONS TO LAKE ERIE COLLEGE:

From the West - Route 90
Drive east on Route 90 to the Route 44 Exit (#200).
Turn north onto Route 44. The next exit is Route 84.
Take this exit. At the exit, turn right at the light and
make an immediate left onto Chestnut St. Stay on
Chestnut for approximately two miles. Chestnut will
dead-end on to Rt. 20 - Mentor Ave. Turn right at the
light. Lake Erie College will be on your right in
approximately one-eighth of a mile.

From the East - Route 90
Drive west on Route 90 to the Route 44 Exit (#200).
Turn north onto Route 44. The next exit is Route 84.
Take this exit. At the exit, turn right at the light and
make an immediate left onto Chestnut St. Stay on
Chestnut for approximately two miles. Chestnut will
dead-end onto Rt. 20 - Mentor Ave. Turn right at the
light. Lake Erie College will be on your right in
approximately one-eighth of a mile.

From the West - Route 2
Drive east on Route 2 to the Route 44 Exit South.
Follow Route 44 South to the first exit (Jackson
Street). At the exit, continue straight three blocks
until you reach Route 20. At the light, turn left onto
Route 20. Lake Erie College is one mile on the right.

From the South
Drive north on Route 44. Take the Route 84 exit. This
exit is the first exit after the Route 90 overpass. At the
exit, turn right at the light and make an immediate
left onto Chestnut St. Stay on Chestnut for approxi-
mately two miles. Chestnut will dead-end onto Rt.
20 - Mentor Ave. Turn right at the light. Lake Erie
College will be on your right in approximately
one-eighth of a mile.
