hio ACEP's leaders have designated Advocacy – ensuring emergency medicine's interests, protecting physicians and their patients and advancing emergency care through legislative advocacy, health policy and regulatory issues - as one of the capstones of the organizational mission. The past year proved to be a dynamic time for Ohio ACEP advocacy. We continued our focus on effective tort reform for emergency care providers with Senate Bill 129, the Ohio ACEP-proposed bill to limit liability for all physicians providing emergency care in compliance with EMTALA. The focus of this bill is to provide appropriately limited liability for these emergency medical providers under EMTALA requirements, to encourage participation in emergency medical care and to improve access to care and quality of emergency care for patients. Previous attempts to enact these improvements have met with stiff opposition from special interests, and Senate Bill 129 has been no different. Despite this resistance, we remain committed to fighting for these reforms on behalf of our members.

Through our membership in the Ohio Alliance for Civil Justice, Ohio ACEP also participated in an amicus brief urging the Ohio Supreme Court to back existing malpractice reforms in a case—*Ruther v. Kaiser*—with potentially far-reaching implications for our members and their protections from unreasonable lawsuits.

In this important election year, Ohio ACEP has also been working to highlight the importance of electing Ohio Supreme Court candidates that understand the need for a stable medical liability climate in Ohio. Justice Robert Cupp and Justice Terrence O'Donnell—both of whom have regularly ruled in favor of common sense medical malpractice reform—are up for re-election and deserve another term on the Court.

Through the legislative leadership of State Rep. Terry Johnson, DO, Ohio tackled the flow of illegally-used prescription drugs, the closure of Ohio's "pill mills," and addressed the epidemic in prescription-drug abuse and unintentional death. Ohio ACEP was at the table representing the interests of emergency physicians as Governor Kasich's Opiate Cabinet Action Team met to discuss the development of guidelines for dispensing opioids. Ohio ACEP was a key member of this Action Team and actively participated in the continual improvement of these guidelines to assure that the guidelines did not replace clinical judgment and continued to allow for appropriate care to meet the unique needs of each patient. The patient guidelines developed were intended to educate our patients about using primary health care providers for ongoing pain management, the requirements of current law and general prescribing guidelines for their safety.

We will continue our work to ensure that unintended consequences of these new guidelines do not hamstring our members' ability to provide their patients with appropriate medications.

Ohio ACEP's staff and lobbying team at Towner Policy Group actively monitored over two dozen bills in Ohio's General Assembly over the past year, commenting on issues relative to Scope of Practice; the designation of stroke centers; increased penalties for the assault of a health care worker; tamper resistant opioid packaging; the authorization of paramedics to administer influenza vaccines in the workplace; and the mid-biennial budget review. Ohio ACEP also successfully lobbied for an amendment to House Bill 417 which requires a health care entity or a physician to send a notice to all physician patients with termination of employment. The amendment exempted emergency physicians from this requirement. Complete

Ohio ACEP's political action committee (PAC) has also been active. The Ohio Chapter ACEP PAC co-sponsored multiple "House of Medicine" events with other medical associations and their respective PACs, including the Ohio State Medical Association, Ohio Osteopathic Association and the Ohio Hospital Association. By hosting and attending events like these, we can raise money for candidates who support our positions on the issues that affect emergency physicians most. At the same time, we gain valuable face time with candidates and elected officials. By doing this, we exert the collective influence of our 1,200-plus members, making our voices heard and our viewpoints known.

hio ACEP is focused on creating and supporting high quality, timely education programs relevant to the practice of emergency medicine. Over the years, Ohio ACEP has expanded the services offered to members, including several world-class continuing medical education courses and acclaimed board review products. The following highlights this year's education accomplishments.

EM Board Certification / Recertification Education

Emergency Medicine Review (EMR) Courses

- Ohio ACEP's EMR course, introduced almost three decades ago, is one of the premier emergency medicine review courses in the country. The course attracts attendees from across the United States and international locations too! Over 30 nationally-known educators are brought in to ensure that participants successfully pass the exam.
- In 2012, e-learning evening review programs will be added to the agenda and new this year, attendees will also receive periodic e-learning emails to help them prepare in the weeks leading up to the course.

EM Oral Board Review Courses

- Ohio ACEP EM Oral Board Review has earned an excellent reputation due to the 1:1 student/instructor ratios and the 5 hours of 1:1 mock case simulations in this one-day course
- Four courses were successfully completed with over 30 Ohio ACEP members serving as faculty
- Case Simulation improvements are continuously being incorporated, and many of the STIM materials have been updated with educational articles to supplement the cases

- Both single case (SPE) and triple case (TPE) demonstrations have been added to enhance the agenda
- Ohio ACEP was invited to share Oral Board exam preparation expertise at ACEP Scientific Assembly 2011 with the Section of Young Professionals.

Carol S. Rivers EM Board Preparation Texts

- Ohio ACEP's revised 6th edition *Preparing for the Written Board Exam* successfully entered the market in January 2011. The Chapter dedicated the new edition to the late Dr. Rivers, crediting her educational endeavors and years of leadership in emergency medicine education.
- Ohio ACEP also began the revision for the 10th edition *Preparing for* the Oral Board Exam with an anticipated publication date of January 2013.
- Subsequent additions of both will continue on the three year revision standard as initiated by the late Dr. Rivers.
- Entering the publication market has also expanded the Chapter's activities at trade shows and at exhibit halls as we focus on maintaining and exceeding established sales of these texts. Ohio ACEP and the Rivers Board Review representatives were present at the Michigan Chapter's In-Service Review for EM Residents, the ACOEP Spring Seminar and ACEP's Scientific Assembly.

LLSA Fast Track Review Course

- The LLSA Course has increased steadily in attendance and with a record number of attendees at the last course offering
- Expert faculty make this course the most educational and enjoyable way to take and pass three LLSA tests in one day
- Ohio ACEP is now seeing many repeat attendees who travel from around the country to take this course every three years
- During the last fiscal year, Ohio ACEP conducted 19 courses for nearly 1,000 physicians.

Ultrasound Education

Basic EM Ultrasound Course

- During the last fiscal year, Ohio ACEP ultrasound trained over 100 physicians from 19 states plus Canada
- The Basic EM Ultrasound courses still consistently fill to capacity and often have a wait list
- Due to Ohio ACEP's reputation as a national leader in ultrasound education, the number of ultrasound companies sponsoring the course has increased, which has allowed the course to offer seven scanning stations and an increased number of maximum attendees
- Course director training has been very successful, and several new faculty have been added to the team
- The two-day course agenda continues to offer more than eight hours of hands-on scanning practice with both live and phantom models
- Participants report an 80% 100% improvement in their scanning skills following the course, including but not limited to, FAST, cardiac, DVT, line placement and transvaginal scanning
- The purchase of a pediatric branch 4-vessel ultrasound training block and two hand and pump central venous access phantom models have proven to add measurable educational value to the course
- In 2012 a combination intrauterine pregnancy & ectopic pregnancy endovaginal model will be added to the course.



In December of 2009, the Ohio ACEP Board of Directors approved a new strategic plan to align mission, finance and organizational sustainability. The board approved the purchase of a new business line to be offered by the Chapter, the Carol Rivers publications (Preparing for the Written and Oral Board Exams in Emergency Medicine). This product dovetailed well with our organizational mission and nationally-recognized strength in EM board review and offered significant new opportunities for financial growth. With this acquisition, Ohio ACEP reaffirmed its commitment to maximize non-dues revenue in order to drive our advocacy mission and chapter operations. As Chapter Treasurer, I have worked to assure greater transparency, revenue growth and more realistic budgeting, which are all consistent with the priorities the board has set for the Chapter. As we end the current fiscal year, I would like to share the following highlights.

- 1. For the 11th year in a row, Ohio ACEP has not increased member dues.
- For the second subsequent year, Ohio ACEP will end the fiscal year with a net profit, increasing member equity and allowing us to add to our investment portfolio. Ohio ACEP's Board Review courses set attendance records, contributing to the Chapter's profitability, and the Carol Rivers publications have added to the Chapter's ability to grow member equity.
- 3. Recognizing market volatility and recent changes in the economy, our Chapter's investment strategy was adjusted to better assure security in the markets and continued growth. This has been accomplished with significantly less portfolio volatility and greater safety for the Chapter's funds.

The Chapter's fiscal year ended April 30, 2012. Copies of the final audited yearend report should be available online in July for your review.

Through its focus on mission, return on investment, priority resourcing, and a solid and responsive investment plan, Ohio ACEP is successfully sustaining your voice in emergency medicine.



Nicholas Jouriles, MD, FACEP 1997-1998

Dr. Nick Jouriles has been tirelessly involved in the specialty of emergency medicine at both the state and national level. He was active in Ohio ACEP Board and Committee activities continuously from 1990 to 1999 and again from 2003 to 2011. In 2002, Dr. Jouriles received the Bill Hall Award for Service, the highest honor Ohio ACEP presents to a past or present member of the Ohio ACEP Board of Directors.

Dr. Jouriles is a respected and accomplished national leader in emergency medicine as well. He served as National ACEP's Secretary-Treasurer from 2005 to 2006, Vice President from 2006 to 2007 and College President from 2008 to 2009. In 2002, Dr. Jouriles was presented with ACEP Council's Meritorious Service Award for his outstanding contributions to the emergency medicine specialty. After chairing the ACEP Education Committee, Dr. Jouriles also served as Course Director for the 2003 Scientific Assembly.

"One 1993 Board meeting, we decided to sponsor a reception at Scientific Assembly. This is what Chapters did, and the 1993 Scientific Assembly would be the closest (Chicago) in years. The 1993 reception was OK, good enough to whet our appetites for another try in 1994. We added a few more Chapters as co-sponsors and did better. I then had the idea to invite all the Chapters. My bright idea was to put all of us in one room so we could visit all evening. So we asked every Chapter and chaired an ever-increasing 'All Chapter' reception.

As the crowd increased, we in Ohio became unnecessarily emboldened. At the 1998 SA in San Diego, we went all out. We reserved the patio. We hired a band. We shipped Frisbees, leis, T shirts and Silly String. As you might imagine, the Silly String was a huge hit. Too huge! As the night wore on, neither person nor object escaped. There was Silly String everywhere. And, shocking as it may now seem, not everyone found humor in what we did. We were threatened with losing our Chapter charter by the then-ACEP Executive Director. The hotel manager was furious. That he signed the shipping receipt for the Silly String, an inconvenient fact, changed his attitude immediately. Miraculously, he went from accuser to accomplice, and we spent all night cleaning up. By morning, all was well.

And that was the last time the Ohio Chapter sponsored a reception."

Dr. Jouriles has been consistently active in education and physician mentorship. He is part of the core faculty for Akron General Medical Center's EM Residency Program. He is also currently Chair of Emergency Medicine at Akron General.

Thomas Hall, MD

1982-1983

Dr. Thomas Hall was instrumental in Ohio ACEP leadership at a time when the fledgling organization was growing into the influential medical association it is today. Throughout his career, he has been active in the arena of Emergency Medical Services. His many EMS activities include serving as Licking County EMS Advisory Board Chairman, EMS Medical Advisor to various local squads around the state and being appointed as the first Ohio EMS Medical Director.

Dr. Hall also helped to guide Ohio ACEP's development as an influencer in politics and policy, serving as Chairman of the Government Affairs Committee and Board Chairman of the Ohio Emergency Medicine Political Action Committee.

"Ohio ACEP involvement was in many ways the completion of my training in Emergency Medicine. After EM residency in Indiana, I was welcomed by the Ohio Chapter because I lived in Central Ohio and was one of the few residency-trained members of the Chapter.

I learned so much from rubbing elbows with leaders in the new field. Department directors like Bill Hall, Bruce Janiak and Mike Ervin gave me valuable insights that I would later use in directing my own department. Executive Director Joan Hesler taught me grace and confidence in dealing with people of all types. Helping shepherd younger colleagues like Rick Nelson, Brian Keaton and Jim Augustine was a real pleasure for me, especially as they grew into terrific leaders in their own right. Activities with OSMA at the same time allowed me to help introduce this new breed of doctors to the house of medicine.

Finally, serving as the first Medical Director for the new Ohio Emergency Medical Services Agency and chairing their 40 person Board of Directors (each with their own agenda) taught me diplomacy, political savvy and patience. It was all quite an adventure, a memory I cherish. I would encourage others to follow my path."

Dr. Hall acted as ACEP representative at a 1982 White House press conference at which President Reagan established the Presidential Commission on Drunk Driving and Seat Belt Usage.

Dr. Tom Hall helped create the Bill Hall Award for Service to Ohio Chapter ACEP and later received the award himself, an accomplishment he describes as a highlight of his time working with the Chapter.

In addition to his impressive contributions to emergency medicine, Dr. Hall is also an active community volunteer in his hometown of Newark, Ohio. He currently serves as one of Ohio's lead Medical Directors for Anthem Blue Cross and Blue Shield.

"My two terms as Ohio Chapter ACEP President were, perhaps, no more and no less notable than the terms of Presidents who preceded me and those who have followed me. What is interesting to note is that many of the initiatives being addressed by our College and individual chapters are longterm initiatives subject to a well-choreographed system of handoffs from one leader to the next, watching the slow and steady progress with landscape changing goals evolve slowly but consistently. I recall debates at the Statehouse regarding Medicaid reimbursement, thwarting the attempts of managed care organizations and third party payors from imposing 'costsaving' benchmarks cloaked in the name of quality of care and patient safety, all while tilting at the windmill of tort reform. Some initiatives have been completed, while others are still moving at glacial speed.

Most importantly, I am truly honored to have been included in this process and entrusted with the Chapter and our membership for this very brief but memorable time. I truly hope that the benefit I received through service to our Chapter has in part been repaid by my efforts to serve our great Chapter and our members in Ohio."

Dr. Klauer is currently Editor-in-Chief for Emergency Physicians Monthly publication and is the Co-Author of two risk management books: Emergency Medicine Bouncebacks: Medical and Legal and Risk Management and the Emergency Department: Executive Leadership for Protecting Patients and Hospitals. "I have great memories of Ohio ACEP and of emergency care in Ohio. I'm so fortunate to have been mentored by a number of the original leaders of Ohio ACEP, but I was most closely guided by Dayton natives, Dr. Mark DeBard and Dr. John McCabe.

During my time with Ohio ACEP in the 80s and 90s, the Chapter was growing and moving into new quarters. Though it was a time of change in our Chapter and in emergency medicine, some of the best lessons in leadership I received were from Ohio's original EM trailblazers. As Ohio emergency physicians, we are blessed to have Dr. Bruce Janiak, Dr. Michael Ervin, Dr. Glenn Hamilton and so many others that call Ohio their emergency medicine home."

Dr. Augustine has also been a member of the National ACEP committees overseeing Emergency Medical Services, Quality Improvement, Benchmarking and Best Practices, and Disaster Preparation. Dr. Gary Katz currently serves as Immediate Past-President of Ohio ACEP and is active on its Board of Directors. As an expert in health policy, he is also deeply involved in physician advocacy. "Furthering Member Value was a core premise for my terms. The challenge that looms largest in my mind in this vein was Ohio ACEP's acquisition of EMEE's Carol Rivers Board Review Program. It certainly felt like a natural fit. Ohio ACEP has founded its national reputation on the quality of the board review programs it has developed. When the Rivers program became available, it was serendipitous. The Chapter was searching for a way to further enhance the value of membership and this seemed like a good opportunity.

Of course, this acquisition only looks like the right decision in retrospect. At the time we had great angst as to whether or not we should strain the Chapter's resources to such a degree. At the time, we were not just in the midst of the recession, but we were at the point where the greatest uncertainty existed for the economy. Thus, considering such a risk in the name of "member value" was one that was carefully considered and often secondguessed (sometimes upon a waking sweat at 3am).

Certainly, precaution was in order, but so was the imperative to strategically grow and diversify the organization.

Fortunately, the Ohio ACEP professional staff and volunteers remain leaders in the industry of EM advocacy and education. Through their diligent work, this transition has exceeded our greatest dreams. I am fortunate to have been at the helm for this transition, though all the credit goes to the team for making it a success.

Congratulations, Ohio ACEP, on 40 years of adding value to the specialty of Emergency Medicine."

Dr. Peter Bell first became active in Ohio ACEP in 1988 when he moved to Columbus. His interest in education led him to serve on the Education Committee and, later, as Liaison to the Emergency Medicine Residents Organization. He remembers his time in these roles as particularly rewarding, having helped to further the education of Chapter members and mentor many young physicians.

Dr. Mark DeBard graduated from the University of Dayton in 1972 and The Ohio State University College of Medicine in 1975. Richard Nelson, MD, FACEP

1992-1993

"During my involvement with Ohio ACEP, I have had the opportunity to know and work with many incredible physicians, some of whom are no longer with us.

Bill Hall of course started Ohio ACEP 40 years ago. He, along with his office assistant Joan Hesler, started this organization from scratch. After his retirement from EM practice, Bill took a position in the Department of Emergency Medicine at Ohio State, where I had the privilege of working alongside him. Bill was a great guy and a great physician, with just the correct amount of wry humor and cynicism to remind you of his EM background.

Dan Storer was on the Board for a number of years and was President just before me. I always thought Dan was the quintessential Board member and President, always encouraging and acknowledging good work. In my subsequent years in leadership positions, I would often find myself trying to imagine how Dan would handle various situations. I, along with Bill Hall, had the honor of presenting Dan with the Bill Hall Award in the early 90s.

Finally, Mike Mackan is someone I had known and respected since residency. He was a year ahead of me at Akron City Hospital's EM program. At a time when EM had just become a specialty but was still perceived somewhat negatively by other residents and attendings, Mike almost single-handedly turned that perception around by being elected chief resident of the entire housestaff and, along with Phil Fontanarosa and me, winning the Walter Hoyt Research Award in 1981."

Since his time as Chapter President, Dr. Richard "Rick" Nelson has continued to serve Ohio ACEP as an Alternate Councillor at National ACEP meetings and as a member of the Government Affairs Committee. He has also served as President of the Columbus Medical Association and continues to serve as a Delegate to the American Medical Association House of Delegates from Ohio. In 2004, he was elected to the American Board of Emergency Medicine, where he currently serves as President. Dr. Nelson is Professor and Vice Chair of the Department of Emergency Medicine at The Ohio State University.

He and his wife Sue live in Westerville. They have three daughters: Amanda, who works in Columbus as an Occupational Therapist; Leigh, who is finishing her first year of the Masters of Public Health program at the University of Michigan; and Kim, who graduated from Duquesne University and lives and works in Pittsburgh.



Eileen Baker, MD, FACEP 2007-2009

Dr. Eileen Baker graduated in 2001 and joined a small, democratic group at Union Hospital in Dover, Ohio.

"My mentors at Summa Health System in Akron had encouraged me to become active with Ohio ACEP, and in 2003, I became an Alternate Councillor. Since 2004, I have also served as a Councillor at ACEP Scientific Assembly. Having been active on the Ohio ACEP Board, I was elected Secretary in 2005 and President-Elect the following year. In 2007, I became Chapter President and served a two-year term. During much of my term as President, I also Co-Chaired the EMS Committee."

During her time as an Ohio ACEP officer and Chapter President, Dr. Baker enrolled at Bowling Green State University to pursue graduate studies in philosophy. She moved to Bowling Green, Ohio in 2008 where she resides today with her husband and two cats. She continues to work diligently on her dissertation in applied ethics and proudly works for Emergency Care Services, Inc. at Wood County Hospital and Mercy Defiance Hospital.

Dr. Baker is still very much involved in Ohio ACEP activities and continues to enjoy serving on the Board.



Brian F. Keaton, MD, FACEP 1991-1992

Dr. Brian F. Keaton is a recognized leader in the fields of emergency medicine, medical education, medical informatics, organized medicine and health policy. He currently serves as the Chief Medical Information Officer (CMIO) for the Akron General Health System in Akron, Ohio.

In 2008, Dr. Keaton completed his service on the ACEP Board of Directors where he was elected both President and Chairman of the Board. After over a quarter century of patient care, Dr. Keaton has retired from the clinical practice of emergency medicine and is focusing his energies on improving the quality, safety and efficiency of healthcare through health information exchange (HIE) and electronic health record (EHR) adoption.

He has served leadership roles with two high-level publicprivate collaboratives focused on health information exchange, the eHealth Initiative (eHI) and Connecting for Health. He was a member of Health & Human Services Sec. Leavitt's American Health Information Community (AHIC) Population Health – Clinical Care Connection Workgroup and co-chaired the eHI Population Health Working Group.

"I went to medical school in Toledo where we spent our first weekend as medical students living with and shadowing a clinician in the community. Through a series of improbable mishaps, I ended up assigned to Bruce Janiak, MD, FACEP, the first emergency medicine resident in the United States. Bruce, who became my first EM mentor, was President of Ohio ACEP which met on Sundays at that time. I attended my first Ohio ACEP meeting on the third day of medical school and have been an Emergency Medicine junkie ever since! My fondest memories are the remarkable people I've had the privilege to meet, call my friends and share a truly thrilling career with... staff, members, spouses and significant others, leaders from other states. It was so much fun helping build the specialty with a group of dedicated individuals who weren't smart enough to know that we were doing the impossible – starting EMRO, developing the 5-day review course, purchasing and designing the headquarters building, hiring a lobbyist, crafting legislation, giving awards to legislators, computerizing the office, chairing national committees, running for the National ACEP Board... it's been a wonderful ride. If I had it to do all over again, I would not change a thing."

Gov. Strickland appointed Dr. Keaton to both Ohio's Healthcare Coverage Reform Advisory Committee and the Ohio Health Information Partnership Advisory Board. Prior to the State of Ohio's decision to provide state-wide HIE services, he was the President & CEO of the Northeast Ohio Regional Health Information Organization (NEO RHIO) which was focused on linking healthcare providers, resources and patients throughout Northeast Ohio. In 2008, NEO RHIO and OneCommunity were awarded an \$11.3 million grant by the Federal Communications Commission to develop HealthNet, a broadband fiber network linking rural and urban healthcare providers in the 22 counties of Northeast Ohio.

He is a tireless worker who has been the recipient of several prestigious state and national awards. He and his wife, Stephanie, live in Akron, Ohio and are the proud parents of two grown children.

In the beainning

hen Ohio Chapter ACEP was founded in 1972, its mission was simple: to promote quality emergency medical care and to represent the interests of Ohio's emergency physicians. In the four decades that followed, the Chapter's scope of activities has expanded greatly and now includes influential work on public policy, world-class educational resources and emergency physician leadership development.

When Ohio ACEP was chartered, the profession of emergency medicine was quite different than it is today. The specialty was not yet an officially recognized medical specialty, and its early advocates sometimes faced resistance in their search for legitimacy. The American College of Emergency Physicians—the first professional organization for emergency physicians—had been founded only four years before in response to increasingly chaotic emergency departments' need for full-time emergency physicians.

The first emergency physicians knew that theirs was a medical specialty distinct from others in the House of Medicine. This emerging medical field had a deeply ingrained spirit of generosity and an inherent duty to serve all patients, without the promise of consistent compensation.

Some would say these unique guiding principles made for equally unique character of the doctors themselves. Emergency physicians thrived on difficult cases and were at their best in the often frenzied setting of the emergency department. In the beginning, they were short on resources, but their energy and determination provided the drive that would help make emergency medicine what it is today.

Continuing Medical Education: an expanded role for the Chapter

Continuing medical education is one of Ohio ACEP's most wellknown functions today, but its first course offering would not be until six years after the Chapter's charter. The first Advanced Cardiac Life Support (ACLS) course was offered in 1978 and instructed by Ohio ACEP President, Dr. John Cahill and future Chapter President, Dr. Bruce Janiak. Two years later, a Dog & Suture Lab was introduced.

Subsequent courses developed and offered by Ohio ACEP included non-clinical topics such as reimbursement best practices and emergency department risk management. In 1982, an early version of the Oral Board Review Course was first offered, giving attendees

With the introduction of the Emergency Medicine Review for the Written Board Exam in 1985, there was a shift in the way Ohio ACEP thought about its role in Ohio emergency medicine. The EMR Written Board Preparation course would later be thought of as the Chapter's "financial lifeline" as it helped to bring in much-needed revenue used to invest back into its membership. Today, the Board Review is a nationally-recognized educational event attracting nearly 700 physicians from all over the world.

In the years that followed, Ohio ACEP would go on to offer a wide variety of course programming, seminars and educational conferences on topics as diverse as rural pediatric health hazards, quality assurance for physician EMS directors and use of ultrasound technology.

Ohio ACEP and EMS

In the same year as the first EMR course, the first Basic Trauma Life Support (now International Trauma Life Support, or ITLS) course

was offered. This was an early indication of Ohio ACEP's enduring commitment to EMS and pre-hospital care. In 1988, Ohio ACEP aggressively pursued a grant to fund its ITLS program. ITLS Ohio is now one of the most successful, recognized trauma life support programs in the nation.

As Ohio ACEP gained members and stability, it would utilize the grant and the expertise of its membership to develop the ITLS program. In 1990, Ohio ACEP offered the first EMS Medical Directors' Course. Designed to provide instruction on the unique demands of the state's EMS medical directors, the course covered everything from disaster planning and operational issues to grant funding and grievance procedures.

In 1995, Ohio ACEP physician leaders and Ohio EMS professionals were instrumental to introducing the first Pediatric ITLS course to cover the special needs of the critically injured child. In addition, these leaders were at the forefront of developing the Pediatric Trauma Life Support: For Prehospital Care Providers textbook, now in its third edition. ITLS Ohio leaders continue to serve as a resource to other chapters for prehospital pediatric trauma care and training.

Today, ITLS Ohio strives to promote awareness of the importance of EMS care, improve the standards of pre-hospital care and act as a resource to all EMTs, paramedics, nurses and physician EMS directors. ITLS Ohio is one of the largest and most active chapters of ITLS, and the chapter leaders have received numerous awards in recognition of their leadership.

Each year, ITLS Ohio holds the Emergency Care Conference, considered Ohio's premier EMS educational gathering and attracts nearly 500 pre-hospital professionals a year. In 2012, the Conference celebrated its twentieth anniversary. Beginning in 1998, Ohio ACEP also hosted the annual EMS Star of Life Awards to recognize the stars of EMS excellence in Ohio. The award ceremony is designed to raise the profile of emergency medical services, celebrate its unsung heroes and reunite EMS caregivers with individuals whose lives they were able to save.

Public Education and Awareness

Throughout the 1980s and 1990s, Ohio ACEP turned significant focus to the general public, promoting awareness of everything from ED overcrowding to public safety.

In 1986, Ohio joined several other states by passing a law requiring seat belt use in automobiles. Though state seat belt laws would later prove effective in reducing the rate of car accident fatalities, the laws

were considered somewhat controversial at the time. Some were unconvinced of the safety of seat belts, while others objected to the laws on grounds of personal liberty.

To help explain the new law and address common concerns, Ohio ACEP and the Wright State University Medical School's Department of Emergency Medicine teamed up to develop an educational brochure. This marked one of the first times Ohio ACEP was involved in developing materials to enhance awareness among the general public.


In a similar public safety initiative, EMRO—Ohio ACEP's body of active emergency medicine residents—designed a brochure entitled "Pull to the Right" as part of a 1989 campaign to educate drivers on the importance of yielding right-of-way to emergency vehicles. The brochure would later receive official recognition by the Ohio Department of Highway Safety and the Governor's Traffic Safety Committee.

Later that year, Ohio ACEP and Mothers Against Drunk Driving (MADD) joined forces to promote their "Tie One On For Safety" campaign against intoxicated driving.

Emergency Physicians: a new political presence in Ohio

Branching out into public policy and advocacy was a logical next step for Ohio ACEP. Though the Chapter had been involved in advocacy

Later that year, Ohio ACEP offered its first Legislative Seminar, allowing members to develop their advocacy skills while participating in an open exchange of ideas with state officials.

In 1990, the Ohio Emergency Medicine Political Action Committee (EMPAC) was established to help elect pro-emergency medicine candidates for public office. One of the PAC's first fund-raising campaigns urged members to contribute "\$90 for the 90s."

Ohio ACEP's increased advocacy efforts yielded results quickly. In 1992, the Chapter used its expanded clout—and its continued commitment to quality pre-hospital care—to help draft and pass a bill creating the State Board of Emergency Medical Services. Dr. Jim Augustine, who would later become Ohio ACEP President, served as the board's first director.

In recognition of the Chapter's reach and influence among emergency physicians and emergency department staff, the Ohio Department of Health awarded Ohio ACEP a grant in 1993 to develop a video tape explaining proper treatment of patient victims of sexual assault. The tape would later be released to Ohio emergency departments to accompany the new state protocol for collection of forensic evidence and treatment of sexual assault survivors. Today, Ohio ACEP is active on the board that revises and improves that protocol on a continuous basis. In 1995, a roundtable meeting with Ohio Attorney General Betty Montgomery, the State Highway Patrol, State EMS Board and other key stakeholders was held at Ohio ACEP headquarters to discuss hospital emergency departments' responsibilities for collecting evidence in suspected cases of drunk driving. The meeting highlighted not just the expanded influence of Ohio ACEP, but the ongoing evolution of the emergency medicine specialty.

Ohio ACEP wielded further legislative sway in 1997, when it helped to draft and push a bill that now defines what constitutes an emergency medical condition, using the "prudent layperson standard." Using this standard, the law requires an insurer to cover an enrollee's emergency treatment up to the point of stabilization and transfer without regard to the date or time the treatment is given.

The 21st Century

The new millennium provided Ohio ACEP with new challenges and new opportunities. Having purchased its office building in 1998, Ohio ACEP's increased equity and financial stability allowed it to focus on rising to these new challenges. As a result, much of the early 2000s were characterized by "thinking big."

In 2001, Ohio ACEP scored a major legislative victory by supporting and helping to pass a bill which extended legal assault protections to emergency department staff. The bill later cleared the Ohio Senate,

EMS Star of Life Award

Held annually since 1999, the EMS Star of Life Awards celebrate excellence in Ohio pre-hospital care

1999

Ohio ACEP gained another policy victory in short order with Senate Bill 281, a major medical malpractice reform bill. The bill was signed into law on January 10, 2003. It continues to provide important liability protections, leading to an improved medical malpractice climate in Ohio.

EMRO, the organization of Ohio emergency medicine residents, had been formed in 1980, early in Ohio ACEP's existence, but a renewed focus on residents prompted the first EM Residents' Assembly in 2002. The event was offered to provide graduating residents the chance to network with colleagues for career advice and meet with potential employers.

In the summer of 2004, US Congressman Tim Ryan of Youngstown met with Ohio ACEP members at Akron General Medical Center for a "white coat" visit, designed to help government officials better understand the profession of emergency medicine and some of its inherent challenges. Gaining the attention of a major legislative player in Washington was a major "get" for Ohio ACEP and illustrated the continued gains in influence enjoyed by the Chapter and its members.

The following year, a grant from National ACEP allowed the Chapter to flex its PR muscles with a public-oriented awareness campaign, EmergencyCareOhio. The campaign included the creation of fact sheets

and media kits, as well as participation in community programs to help improve health care access and quality. The campaign also focused on reforming problems such as overcrowding, an unfavorable medical liability climate and reimbursement issues.

A "white coat" rally at the U.S. Capitol Building was organized by ACEP in 2005, and the Ohio Chapter was well-represented as emergency physicians from around the nation turned out in force to urge Congress to preserve access to emergency care for all Americans.

In January of 2006, the American College of Emergency Physicians released the first-ever "National Report Card on the State of Emergency Medicine". Weak public health/injury prevention and an unstable medical liability climate earned Ohio a "C+" grade, and Ohio ACEP utilized the report card as an important public relations tool to spread awareness through radio and print media.

In 2007, Ohio ACEP began a major new initiative combining education, advocacy and leadership development. The Leadership Development Academy—designed to give members an invaluable opportunity for leadership and advocacy training—was an important milestone in the way Ohio ACEP thought about advancing the emergency medicine specialty. Recognizing that an emergency physician trained in the art of leadership is the specialty's best possible advocate, Ohio ACEP made the program a primary focus.

Under the leadership of Government Affairs Chair, Dr. Catherine Marco, Ohio ACEP drafted legislation that would grant qualified civil immunity to physicians providing professional emergency care in compliance with the federal law, EM-TALA. Senate Bill 86 was introduced by Senator Steve Buehrer, and, as expected, the bill faced stiff opposition from moneyed special interests. Senate Bill 86 cleared the Ohio Senate, only to stall in the House.

Though the bill did not pass in the 127th General Assembly, its provisions were combined into a new bill in the following legislative session. This signaled a long-term willingness for Ohio ACEP to pursue a difficult policy in the face of entrenched interests determined to stop it.

Today

Ohio Chapter ACEP started as a small group of doctors who envisioned an organization that would help them ensure the best possible emergency care for their patients. Since then, emergency medicine has become recognized as a vital and respected part of our health care system, and Ohio ACEP has consistently been at the fore-front of fighting for that recognition.

Ohio ACEP is now active in legislative and judicial matters, and its influence allows the organization to hold the line against bad policy that would weaken emergency care in Ohio. The Chapter's perspective is sought by candidates and elected officials alike, and many of its members are state and national leaders in their field. Physicians from around the world attend Ohio ACEP's acclaimed educational offerings.
