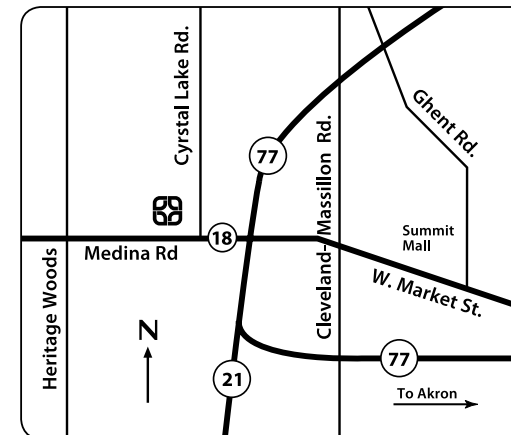
Directions to Akron General Health & Wellness Center - West
