

Legislative Successes in 2014



Led by the OPA Legislative team (pictured on the opposite page), pharmacists and student pharmacists attended OPA Legislative Days, met with their legislators and gave testimony in both chambers ultimately affecting four pharmacy bills being signed into law in 2014. Pictured above is Governor John Kasich signing SB 258: Pharmacy Audit Standards. Also present for the signing were (from left) Greg Bennett, Ernie Boyd, Larry Schieber, John Coler, Antonio Ciaccia and Michelle Fitzgibbon.



Recent Accomplishments

- HB 394 signed into law, which allows pharmacists and pharmacy interns to administer all CDC-recommended vaccines to patients 7 years of age and older
- SB 258 signed into law, creating audit guidelines to protect pharmacies from wasteful & abusive audits
- HB 326 signed into law, which allows pharmacists and pharmacy interns to fit diabetic shoes
- Successfully combated language that would have required pharmacists to review OARRS report for every CII and opiate prescription
- Protected compounding pharmacies from over-burdensome regulations

What we are fighting for now

- PBM legislation that will include pricing transparency, licensure and fairness in contracting provisions
- Making fundamental changes to collaborative agreement laws
- Fair and reasonable reimbursement and dispensing fees
- Provider status for pharmacists
- Payment for Medication Therapy Management services

OPA hosts first-ever Community Pharmacy Advocacy Summit

The first-ever OPA Community Pharmacy Advocacy Summit was held November 18, 2014, in Columbus, to open dialogue between community pharmacy owners, managers, and employees, and their legislators. OPA partnered with the National Community Pharmacists Association and engaged OPA community pharmacy leaders for this special advocacy day to tackle critical issues and legislation impacting community pharmacy practice. Pharmacists learned about the issues, heard from legislators working in these areas, and visited with their elected officials to discuss the issues one-on-one. The issues included pending pharmacy audit legislation, mandatory mail order, PBM contracting challenges, and maximum allowable cost (MAC) pricing.

Student Legislative Day Success!

On March 24, more than 250 students attended OPA's Student Legislative Day at the Statehouse in Columbus. An opportunity for students to learn more about the legislative process, Student Legislative Day is the first step to becoming actively involved in advocating for the profession.

During this one day event, students were walked through the process of meeting with a legislator, learned about important pharmacy issues and advocacy opportunities and participated in prearranged meetings with their state legislators. Students from all seven schools/ colleges of pharmacy met with more than 90 legislators and legislative aides. During these meetings, they were able to share real-life pharmacy experiences with legislators and educate them on the practice of pharmacy in Ohio. For






