## Immunization Update

Legislation now allows for pharmacists and student pharmacists to administer all CDC-recommended immunizations to persons seven years of age and older.

Using a case-application approach, this session reviews recent changes in recommendations for immunizations, the available flu vaccine products and their effectiveness, and strategies to prevent vaccine administration-related errors.
