

New CSD Membership Categories and Savings Levels

<u>Eligible for CSD Savings</u>	<u>CSD Savings at next renewal</u>	<u>Not eligible for future CSD Savings at next renewal**</u>
TRAN	50%	TRAN1**
CSD1*	40%	CSD1X**
CSD2	30%	CSD2X**
CSD3	20%	CSD3X**
CSD4	Full Dues	CSD4X**

* CSD1 replaces the current HALF membership category.

** If a member doesn't maintain continuous membership (dropped activity record), he/she will no longer be eligible for future CSD savings at next renewal.

Illustration: If a member's membership category is CSD1X, he/she is no longer eligible for future CSD savings based on lapse, and must pay full dues if he/she decides to rejoin.

Category	Definition	CSD Savings at next renewal
TRAN <i>(No change from current)</i>	Member who is eligible for 50% off national and chapter dues when their student membership ends. Has 6 months from end of student membership to renew at reduced rate.	50% off national and 50% off chapter dues.
CSD1 <i>(formerly HALF)</i>	First year post TRAN member who saved 50% off national and chapter dues (formerly HALF) when they renewed. No grace period beyond the usual 30 day grace period. <i>Note: Initially, members were assigned to the appropriate CSD membership category based on pilot savings eligibility.</i>	40% off national, and 40% off participating chapter dues or 0% off nonparticipating chapter dues.
CSD2	Second year post TRAN membership and saves 40% off national, and 40% off participating chapter dues (or 0% off nonparticipating chapter dues.) No grace period beyond the usual 30 day grace period. <i>Note: Initially, members were assigned to the appropriate CSD membership category based on pilot savings eligibility.</i>	30% off national, and 30% off participating chapter dues or 0% off nonparticipating chapter dues.
CSD3	Third year post TRAN member who saved 30% off national and 30% off participating chapter dues (or 0% off nonparticipating chapter dues.) No grace period beyond the usual 30 day grace period. <i>Note: Initially, members were assigned to the appropriate CSD membership category based on pilot savings eligibility.</i>	20% off national, and 20% off participating chapter dues or 0% off nonparticipating chapter dues.
CSD4	Fourth year POST TRAN member who saved 20% off national and 20% off participating chapter dues (or 0% off nonparticipating chapter dues.) No grace period beyond the usual 30 day grace period.	Full Dues
TRAN1 <i>(No change from current)</i>	Member missed the 6 month grace period to save 50% and now owes full dues to renew based on lapse.	Full Dues
CSD1X	Member missed the 1 month grace period to save 40% and now owes full dues to renew based on lapse.	Full Dues
CSD2X	Member missed the 1 month grace period to save 30% and now owes full dues to renew based on lapse.	Full Dues
CSD3X	Member missed the 1 month grace period to save 20% and now owes full dues to renew based on lapse.	Full Dues
CSD4X	Member missed the 1 month grace period to renew when dues moved to full dues based on lapse.	Full Dues
