Reports of the Officers and Executive Committee:

Vice President:	1. Mrs. Barbara Klatt welcomed Bishop Holloway upon his return from his sabbatical leave. She also thanked and praised Pr. Suzanne Darcy Dillahunt for stepping into the role of Acting Bishop during Bishop Holloway's leave.
	2. The ELCA Social Statement on The Body of Christ and Mental Illness is now available for public consumption. The Synod newsletter containing information on the Statement is also available. A Mental Illness presentation will be provided as a part of the 4G project.
	3. The Synod staff is busy preparing for the tier two meetings of the God Sightings program. Members of the Synod Council are encouraged to attend. The God Sightings Program takes the concept of stewardship beyond just dollars. It included the concept that everyone is "the synod", not just the Synod office and staff. Participants are urged to take part in the conversations occurring at the events, and then the participants are expected to take the conversations back to each of the Synod's congregations.
	4. Mrs. Klatt shared with the Synod Council that of 61 synods of the ELCA, 29 synods reported an increase mission support for 2012 and 32 synods reported a decrease in mission support for 2012. Mission support by synods ranged from 39% to 52% for the same period of time.

Treasurer:	1. For the month of January, 2013, the Synod received \$281,000 in mission support. For the year ending January, 2013, the Synod received \$1.686 million allowing the Synod to share 40% with the ELCA and allowing the Synod to break even for the year.

- Bishop: 1. Bishop Holloway thanked those who sent him notes and cards welcoming him back from his sabbatical leave. He stated that those expressions of welcome were very meaningful to him. The Bishop expressed gratitude to his assistants, staff, officers, and to Pr. Suzanne Darcy Dillahunt for everyone's continuing support during his leave of absence.

2. The Bishop reported that he engaged in some light study and reading.

3. While on leave, Bishop Holloway attended the Conference of Bishops in Chicago, presided over a Faith Trek gathering, attended the annual Luncheon for Retired Pastors and Widows, and performed two funerals.

4. The Bishop also reported that Portico is in the process of deep change. He hoped to be able to share an update on Portico with the Synod Council but cannot because of the continuing process of change. No new action has been taken on LIFT.

2012 Year End Fiscal Report

The Synod received \$281,000 in mission support for the month of January, 2013, and \$1.686 million for the year. The office operation line item showed a credit of \$53,000 for the year due to the resolution of the real estate tax dispute with Franklin County Auditor which produced a refund. Therefore, the Synod ended the year in black subject, however, to audit which should be completed mid April, 2013.
