
Understanding How We Got Here...

- Portsmouth is the seat of Scioto County and has a population of 17,779
- Scioto County has a population of 72, 361
- A long history of addiction
- Over the last three decades Scioto County and the surrounding region have been deeply impacted by the opioid crisis and the subsequent overdose crisis.
- The "Pill Mill Capital of the US"
- 162 Doses for everyone adult and child in the county

Understanding Where We Are Now...

- Between 2015 and 2022 approximately 531 lives have been lost to overdose.
- In 2020 Scioto County had the highest per capita overdose fatality rate in the history of Ohio.
- Between 2015 2020 Scioto County had the highest per capita overdose fatality rate in the state.
- Current fatalities are predominantly polysubstance and are frequently a combination of Fentanyl and a stimulant.
- Xylazine is impacting wound care and overdose response.




Why does it matter?

- We all use harm reduction everyday
- Little h, little r, harm reduction and Big H, Big R Harm Reduction
- Harm reduction is both a set of practical strategies and actions that seek to reduce the risks associated with using drugs and a philosophy and social justice movement built on the history of direct action and advocacy of many marginalized communities and people who used drugs during the AIDS crisis in the US.
- Continued advocacy, power building, expanding resources and available tools.

SO HOW CAN RURAL HARM REDUCTION BE

DIFFERENT?

- It is almost always personal and not just professional.
- The impact of culture and the importance of cultural competence.
- Religion and the faith community.
- Deeply entrenched stigma and community trauma
 - Poverty and other Social Determinants of Health
 - Substance Use and Mental Health
 - Medication as a part of recovery
 - Harm Reduction.
- Community Champions
- Relationship building and trust





ABOUT SHRPS

SHRPS or Supportive Harm Reduction Program and Services is the second oldest syringe program in the state of Ohio, created in 2011 by Bobbie Bratchett, then the Rural Aids Program Coordinator, to respond to the needs of the community.


Provides services to folks living in over 60 zip codes across five states (Ohio, Kentucky, West Virginia, Pennsylvania, and Indiana.

Between 200-300 interactions with members per week.

Some members drive 1 to 1.5 hours to access services due to location.

Many long time members.

Many members employed full time.



In 2021, 93% of the overdose deaths that occurred in Scioto County had fentanyl present.

WHAT WE DO

Syringes

A range of sterile syringes are provided to program members. Program also disposes of used syringes. Exchange of syringes is required and only once per week attendance.

Xylazine Test Strips

With the emergence of Xylazine, also known as "tranq", these test strips are aiding members in making safer choices for themselves and those around them.

SHRPS is more than syringes, naloxone, and wrap around services. It is also a welcoming space where members are able to come in and access a meal, something to drink, and receive care and support. It's community.

Fentanyl Test Strips

SHRPS has been distributing Fentanyl Test Strips since 2017 and collecting both result data as well as data on result impact.

Viral Hepatitis

On site instant testing and confirmatory testing with direct linkage to Hepatitis C treatment by mail.

Broad Medical Services

Primary care, wound care, reproductive healthcare, referral services, lab work, prescriptions

HIV Services

HIV testing on site with linkage to PrEP, PEP, and Ryan White Part B and C services

STI Testing & Treatment

STI testing is provided on site with linkage to applicable treatments when needed.



In 2022 46 program members were cured of Hepatitis C, preventing approximately 1000 new transmissions.



Member guidance and feedback has been integral to the development and expansion of SHRPS. The relationships we have built and the environment that has been created allows for meaningful discussion

Navigation Linkages can be provided to mental

Linkages can be provided to mental healthcare, housing assistance, transportation, vital statistics, food assistance, and more and are self directed.

Medicaid Enrollment

Navigators are also certified to perform Medicaid enrollments to any members seeking medical care and can check Medicaid status for members if needed.

IMPACT

Harm reduction creates profound change and saves lives



NALOXONE

In 2021, SHRPS members performed 1600 naloxone reversals.

In 2022, members performed almost 900 naloxone reversals.

In 2021 Scioto County saw a 25% reduction in overdose fatalities, and 2022 is showing a continued reduction in overdose fatalities for the second year in a row.



SHRPS data has been able to demonstrate on a local, state, and federal level the efficacy of harm reduction.

Stimulant Contamination

Baseline in 2020 showed a roughly contamination rate. Current contamination levels are now roughly 65%

Positive Results

Data collected over 2021 showed that SHRPS members used positive results to make safer choices with folks choosing not to use the substance, using less, not using alone, and having naloxone present.



SHRPS currently has over 3000 unique IDs enrolled in the program and growth regarding new members continues to be consistent.




South Portsmouth
