# Bill Review



- ▶ PA has reviewed nearly a dozen bills this session, including the state budget bill.
- ▶ Individuals assigned for bill review prior to PA meeting
- ▶ Follow-up on bills with highlights and status updates completed each meeting

# Examples:



- ▶ HB 7: Infant and maternal mortality
- ▶ HB 207: Special use pools /ODH and Dept. of Agriculture authority
- ▶ SB 9: Medical marijuana regulations
- ▶ SB 16: Perishable food donations–liability protection
- ▶ HB 70: Require school policy for OTC meds
- ▶ SB 119: Solid waste fees and regulations
- ▶ HB 33: Budget, over a dozen issues impacting LHD's

# More PA work:

- ▶ Public health nuisance abatement issues
  - ▶ Coalition building and partnerships (non-profits, CCAO, OTA, OPHA, OEHA)
  - ▶ Planning and workgroups around enhancing public affairs efforts
    - Strengthening public health workgroup
    - Food Insecurity workgroup
    - Plumbing Workforce subcommittee recommendations

# HB 33, Biennial Budget Bill

- ▶ Key issues included:
  - Preemption of local tobacco regulations
  - Statewide vaping ban
  - LHD subsidy
  - Additional funding for LHD CHA's and CHIP's
  - Drywell regulations
  - REHS regulations and training
  - Local levy and tax issues impacting LHD's
