I am honored to be nominated for Second Vice-President for CSCA. I believe at my core that communication constructs our relationships and realities; the communication with friends and colleagues at CSCA has shaped many of my most meaningful relationships (all my advisors and research partners), my perspective on communication, and my scholarship in interpersonal and instructional communication. CSCA represents a collage of the intellectual inspiration I have experienced, collectively spanning five states within the association. I am proud of CSCA's growth, offering new members similar enrichment opportunities. If elected, I will continue to work on recruitment and to link association members.

As a Western Kentucky University faculty member, my leadership experience includes serving as Basic Course Director and Undergraduate Curriculum Chair. I have chaired CSCA's Communication Education and Basic Course Interest Groups as well as the Cooper Award Committee. I have also recently been elected NCA Instructional Development Division Vice-Chair. These opportunities have allowed me to give back to these associations and garner planning experience. Leadership positions such as Second Vice-President that entail conference planning provide opportunities to focus on specific themes. Communication conferences offer a chance to explore how communication creates and re-shapes our culture, education, workforce, politics, and relationships. "Create" could serve as an important theme, centering both on how communication constructs our lives in so many ways as well as how communication can facilitate meaningful change. For example, as new communication technology impacts nearly every aspect of our lives, there is no discipline better suited to address these advancements and challenges than ours, making the forward thinking, discussion, and collaboration at regional conferences perhaps more imperative than ever. As a researcher, I have tried to play a small part in advancing understanding of the role communication technology plays in the academic context. While individual research can facilitate improved practice, providing leadership at higher levels provides a valuable opportunity to make a much larger contribution. Interest groups across CSCA can collectively produce scholarship and discussion, serving as agents of change by suggesting how communication can construct new realities in relational, intercultural, rhetorical, and organizational contexts. My vision as conference planner would be to facilitate dialogue to construct knowledge that can address the communication challenges of present and future eras, helping to create and explore new communicative realities with practical applications. I would work with the interest group chairs to facilitate spotlight panels within and across interest groups focusing on how communication technology is constructing new realities, analyzing the role communication plays in constructing relationships, knowledge, and norms in various contexts, and how communication can promote change.

As Second Vice-President of CSCA, I would apply the same work ethic, forward thinking, and determination I have dedicated to all my scholarly efforts.
