BICSI Lab to open at Dayton Electrical Training Center

The Building Industry Consulting Service International (BICSI) is a professional association supporting the information technology systems (ITS) industry. ITS covers the spectrum of voice, data, electronic safety and security, project management, and audio and video technologies. It encompasses the design, project management, and installation of pathways, spaces, optical fiber- and copper-based distribution systems, wireless-based systems and infrastructure that supports the transportation of information and associated signaling between and among communications and information gathering devices.



BICSI certifications are considered the de facto certification for cable installers and designers. BICSI established its credential programs to provide a level of assurance to the industry and to consumers that an individual has knowledge in a designated area of ITS design or installation. Candidates for BICSI credentials are required to show industry experience and pass rigorous exams. Those who pass must adhere to strict standards of conduct and keep their knowledge current through continuing education.

With the opening of the new BICSI lab in Dayton, apprentices will no longer need to travel to another site to test for certification. In addition, all apprentices in the Installer Technician program will now be able to graduate with certifications for: ITS Installer 1; ITS Installer 2 Copper; and ITS Installer 2 Optical Fiber. Certifications must be renewed every three years. After an Installer Technician Journeyman has completed three years of on the igh experience, they gualify to test for ITS Technic

three years of on-the-job experience, they qualify to test for ITS Technician.



What is BICSI?

BICSI provides information, education and knowledge assessment for individuals and companies in the ITS industry. They serve more than 23,000 ITS professionals including designers, installers, and technicians. These individuals provide the fundamental infrastructure for telecommunications; audio/video/ life safety; and automation systems. Through courses, conferences, publications and professional registration programs, BICSI staff and volunteers assist ITS professionals in delivering critical products and services, and offer opportunities for continual improvement and enhance professional stature. BICSI membership spans nearly 100 countries.

The BICSI lab will house two complete work stations. BICSI is particularly excited about the new lab in Dayton because it was built with four wiring methods: under the floor, in the wall, above the ceiling and with cable trays. So the apprentices will have an opportunity to learn hands -on how to run cable utilizing all four methods. (Most labs only provide training in two or three methods).



BICSI has established strict guidelines for operating a lab. There are six pages of listed inventory that must be maintained in the lab including racks, cables, and tools (personal kits and community tools). Photos must be submitted to BICSI of every stage of construction and a final video of the entire lab is required prior to certification.

This lab would not be a reality without the hard work of JATC Training Director Dick Brooks and VP Chapel-Romanoff Technologies Dennis Severance. Working with the many vendors that support the apprenticeship program, the majority of materials were donated. Sponsors include: Structured Innovations, Belden, Panduit, Klein Tools, Leviton, Hubbell, and Mohawk. According to Dennis Severance, "The materials donated by these vendors are invaluable. We appreciate their commitment and support."

Hundreds of volunteer hours were contributed to construct the lab. Dan Florhe and Jeff Runyan have devoted their time and are also now both trained as instructors. Kenny Smith volunteered many hours and will soon receive instructor training as well. A big thanks goes to Mike Evans and Ben Dehart for their assistance in building the structure of the lab.

There are 100 BICSI labs and 75 of those are IBEW/NECA/NJATC facilities.

Clark State breaks ground on \$7.4M student center. Congratulations To BX Dayton, SMRCA and MCAD Members Involved on the Project.

Clark State Community College broke ground late last week on a student center it says will bring together resources for student success.

The school is consolidating many of its student services into the Karen E. Rafinski Student Center, a 17,600-square-foot building at its main Springfield campus named for a past school president.

Among the amenities at the new center will be the offices of accessibility services, academic advising, bookstore, dining facilities and a large amount of study and lounge space. University officials say such space isn't currently present on the campus and could push up student success.

This comes as the school also looks at partnerships, such as existing enrollment plans with Wright State University. Sinclair Community College has also been looking to establish a presence in Greene County alongside Clark State.

The state is footing half of the cost of the project, with Clark State taking the other half.

Contractors responsible for the work include: Griffith Sheet Metal (SMRCA Member), HVAC; Roger Storer & Son (DBX Member), plumbing; Ohio Electric Service (DBX Member), electric; and Bryce Hill DBX and MCAD Member), concrete, block and brick.

Clark State is the fifth-largest college or university in the Dayton region with roughly 5,000 students, according to DBJ research.

1099s: A little form with a painful bite



When Congress tried unsuccessfully to expand the Form 1099 filing requirements a couple of years ago, at least one thing was accomplished. It raised awareness of an important IRS business reporting rule. And at \$100 per infraction, the penalty for ignoring this regulation can be painful.

That's right; the IRS can fine you \$100 for each 1099 form that you fail to file, up to a maximum penalty of \$1.5 million. The most common Form 1099 is the 1099-MISC, which is used to report payments of \$600 or more to vendors who provide services to your business. Examples include payment for repairs, accounting services, consulting fees, and legal advice. Normally if the vendor is incorporated you do not need to send them a 1099-MISC, but there is one important exception. All payments to attorneys must be reported, whether they are incorporated or not.

Timely filing of the Form 1099-MISC is also critical. The form must be filed with the IRS by February 28 (unless you file electronically). But you must provide the vendor a copy of the form by January 31. Electronic filing is optional if you file fewer than 250 forms. If you have 250 or more forms to file, you are required to file electronically. The deadline for electronic filing is March 31.

There are a few more twists. If you pay a vendor for parts and services, you must include the total of both of these on your form as long as the parts or materials were incidental. If materials were the predominate nature of the payment, they are left out. Reporting is also required if you provide nonemployees taxable fringe benefits or pay fees to your board of directors.

Looking for an easy solution to these requirements? Pay all your vendors by credit card. You do not have to report payments made by credit or debit card, or by services like PayPal. The bank or thirdparty payment provider is required to report those transactions.

There are other types of Form 1099s to watch for. A Form 1099-INT is used to report interest payments of \$10 or more to an individual in the course of a trade or business. Form 1099-R is used by investment companies to report distributions from retirement accounts and annuities. And businesses that make loans are required to disclose canceled debt on Form 1099-C if the amount is \$600 or more. Half of Construction Apprentices Quit Training Within First Year, Report Says

Oct. 18 — Nearly half of all construction apprentices in a registered apprenticeship withdraw from the program within their first year of training, the Aspen Institute said in report released Oct. 17.

The Aspen Institute Workforce Strategy Initiative's review and analysis of data from the Office of Apprenticeship and state agencies determined that women and minority apprentices, apprentices without a formal high school education, and apprentices without pre-apprenticeship credits are more likely to cancel their participation in the programs.

"While the challenge of apprenticeship cancellation does not appear to be new, fresh conversations and efforts to improve completion rates have been sparked by concern over the many people retiring in the construction industry, the loss of construction workers during the recession, the high cost of training apprentices, and low completion rates by women and minorities," the report said.

To increase the rate of retention, the institute suggested that the sponsors of construction apprenticeship programs make improvements in the structures for mentoring, evaluating, educating, and supporting apprentices within their first year of training.

Range of Reasons for Cancellation

The institute found that canceled apprentices, students who left the training programs, withdrew from their apprenticeships citing four overarching challenges to completing their training.

During interviews conducted by the institute, many construction apprentices said financial security was one of their reasons for quitting because of frequent layoffs, limited job opportunities and low wages for apprentices. Some of the canceled apprentices had poor saving habits and lacked money management skills, which made it hard for them to maintain financial security, the report said.

Some apprentices withdrew from their programs because of the workplace environment on construction sites. "A lot of construction work is physically tiring, dirty and occurs outside in tough weather. Apprentices may enter construction work without fully understanding the job's nature and demands," the report said.

The report added that some canceled apprentices experienced hazing and abuse by other workers on construction sites.

Other construction apprentices canceled their participation in the program because they had limited math and reading skills and needed more education in those areas. The report said some apprentices had trouble balancing work, family and school schedules. Others reported having substance abuse issues or mental health problems.

During reviews of apprenticeships with high rates of completion, the apprentices, as well as journey workers, employers and program officials said participants benefited from a supportive workplace environment emphasizing career development.

"Interview subjects broadly agreed that program completion is more likely when apprentices have a personal commitment to a construction career, strong determination, a firm work ethic, and a willingness to learn; a supportive workplace that prioritizes skills and career development; and a support network that eases the burdens and obstacles of apprenticeships," according to the report.

Recommendations to Apprenticeship Sponsors

Researchers said state and federal policy makers could play a role in increasing apprenticeship retention and completion rates. They recommended that policy makers advocate for more investments in infrastructure projects to create more jobs for construction workers.

State and local officials can support apprenticeships by investing more resources in collecting data on apprentice outcomes, such as reasons for withdrawal or for success, according to the report.

Policy makers and investors in apprenticeships could also support and evaluate each program's mentoring and retention efforts.

For apprenticeship program and industry leaders, the institute recommended:

• additional tutoring and classes to help apprentices who need to improve their reading and math skills;

• a formal mentoring program that provides apprentices with "ongoing attention and regular evaluation";

- creation of training schedules that better accommodate apprentices' work schedules and family commitments;
- increased oversight of apprentices' job rotations to ensure that participants get the necessary on-the-job training; and

• increased collaboration with community partners and schools.

Researchers also said industry leaders should "speak out more against abusive behavior directed at apprentices," and emphasize the need for a workplace environment that doesn't tolerate abuse or hazing of apprentices and other workers.

OSHA Announces Proposed Rule Change for Workplace Injuries and Illnesses

Currently most employers with 10 or more employees are required to maintain the OSHA 300 Log and the 300A Summary. The 300A Summary has to be posted by February 1st of the following year and be posted until May 1st of that year. After that date it can be taken down and filed. Each affected company is required to maintain these records for at least five years. OSHA Compliance Officers are required to review the company OSHA records during an OSHA inspection.

Each year in the spring companies will receive a request to send in their OSHA Recordkeeping data to the Bureau of Labor Statistics (BLS). The BLS then complies the data for each NAIC Code. (North American Industrial Code.) They then post online during the fall the latest OSHA Incident Rates for each NAIC Code. Companies can pull this information up on the OSHA website to see how they compare with other companies in their NAIC Code. Also, OSHA develops their annual inspection list of companies who have a DART Rate higher than the National average for their Code. The DART Rate is all the Lost-Time cases and the Days of Restricted cases added together. Those companies with high DART Rates are subject to a full OSHA style inspection. On average in Ohio there are over 1200 companies each year who are subject to a DART type safety inspection.

November 7, 2013 OSHA issued a new proposed rule to require employers with more than 250 employees who are required to keep the records to electronically submit their records on a quarterly basis to OSHA. Companies with 20 or more employees in certain industries with high injury and illnesses rates will be required to submit their 300A Summary electronically on an annual basis.

This change is being proposed because there are over 3 million Occupational Injuries and Illnesses that are reported to the Bureau of Labor Statistics each year. The proposed changes according to Dr. David Michaels, the Assistant Secretary of Labor for OSHA, will provide better access to data for employers, employees and the government that will encourage earlier abatement of hazards. It also hopes that this will result in improved safety programs that will reduce workplace hazards and prevent injuries, illnesses and fatalities.

This proposal does not add any new additional record-

keeping requirement. It only modifies an employer's obligation to transmit these records to OSHA.

The public will have 90 days – through Feb. 6, 2014 to submit written comments on the proposed rule. On January 9, 2014, OSHA will hold a public meeting on the proposed rule in Washington, D. C.

OSHA plans to eventually put the data online as encouraged by President Obama's **Open Government Initiative.** This will help OSHA target resources more effectively by identifying workplaces where workers are at great risk. This will also allow other employers to compare their injury rate to others in the same industry according to OSHA.

This change if adopted would not take effect until January 1, 2015. It will provide OSHA quick results on injuries and illnesses taking place at the companies required to maintain the OSHA records. This will not result in increased inspections, but will change which companies get targeted in the future.
