

Nursing Home Surveys and Letters in your Enhanced Information Dissemination & Collection (EIDC) Account (03/16/26)

The Centers for Medicare and Medicaid Services (CMS) is in the process of phasing out their survey of record system ASPEN and replacing it with a new web-based platform called Internet Quality Improvement & Evaluation System (iQIES). Nursing home (NH) provider records have migrated into iQIES and your EIDC account has now been set up to receive these iQIES-based surveys. You will now receive NH information in these areas of your EIDC account:

- **NH surveys:** Your CMS Form-2567 will now arrive under your NH **certification** profile in EIDC.

For most NHs in EIDC, you have a licensure profile account (where you renew your license) and you have a certification profile account. The certification account’s facility ID does not contain an “L”. The “L” designates your licensure account. In the example below, your certification profile is highlighted and will now contain your federal-based NH surveys:

- **NH notice letters** (addresses a survey): Your notice letter will now arrive under the **POC Documentation** tab within the applicable Event ID.

NOTE: The nomenclature for Event IDs in iQIES has changed. The Event IDs from iQIES hold a combination of six letters and numbers followed by -H1 (health survey) or -L1 (Life Safety Code survey). The same first six letter and number combination will follow the survey and its revisits until full correction of the survey and its citations (i.e., 1F1745-H1, 1F1745-H2, 1F1745-H3, etc.).

INSTRUCTIONS FOR ACCESSING YOUR NURSING HOME (NH) SURVEY IN EIDC

1. When a NH survey has been sent to your EIDC account, the email accounts on file with EIDC will receive an email notification:


