22, decreased from 25 at the start of 2023





Hawaii Regional Processing Center (RPC) Contract


- In 4Q2023, BOH concluded its evaluation and analysis of their overall relationship with the RPC and ultimately decided to discontinue RPC operations.
- In January 2024, BOH announced that effective August 30, 2024, RPC services would be terminated.
- As of April 3, 2024, of the 22 remaining RPC members:
 - 2 FI's have already terminated their relationship with the RPC
 - 7 FI's have scheduled their termination date with BOH
 - 13 FI's have not confirmed their termination date with BOH
 - Aloha Pacific FCU, Catalyst Corp FCU, Ewa FCU, Garden Island FCU, Gather FCU, HI
 Comm FCU, HI County Emp FCU, Hawaii FCU, Hawaii Schools FCU, Hickam FCU,
 Hotel & Travel Ind FCU, Maui FCU, Oahu FCU




Started year strong, no processing delays in the first 4 months of 2023!














- May DR Fortress power outage issue and BOH internal ACH system error attributed to delays
- > July Nationwide FRB system issue which caused delays in files being received from the Fed










December – BOH internal system issue which attributed to the delay in processing








