First to enact: Boston on 2/2/12.

* has the original cigar pricing policy requiring single cigars be sold for at least \$2.50; two-packs for at least \$5.00; three-packs for at least \$7.50 and 4-packs, or larger, at market rate (no minimum).

POSSIBLE LANGUAGE: Cigar: Any roll of tobacco that is wrapped in leaf tobacco or in any substance containing tobacco with or without a tip or mouthpiece not otherwise defined as a cigarette under Massachusetts General Law, Ch. 64C, §1, Para. 1.

1. No person shall sell or distribute or cause to be sold or distributed a single cigar unless such cigar is priced for retail sale at two dollars and ninety cents (\$2.90) or more.
2. No person shall sell or distribute or cause to be sold or distributed any original factory-wrapped package of two or more cigars, unless such package is priced for retail sale at five dollars and eighty cents (\$5.80) or more.
