DEFINITION: Educational Institution: Any public or private college, normal school, professional school, scientific or technical institution, university or other institution furnishing a program of higher education.

REGULATING LANGUAGE: No educational institution located in [city/town] shall sell or cause to be sold tobacco products. This includes all educational institutions as well as any retail establishments that operate on the property of an educational institution.
