

## What is Nicotine Free Generation "NFG"?

## Brookline's NFG Language

Prohibition of Sales to Minors

No person, firm, corporation, establishment, or agency shall sell tobacco or ecigarette products to a minor anyone born on or after 1/1/2000.

Required Signage

The owner or other person in charge of an entity authorized to sell tobacco or e-cigarette products at retail shall conspicuously post a sign stating that "The sale of tobacco or e-cigarette products to someone under the age of 21 years of age born on or after 1/1/2000 is prohibited.

Identification

Each person selling or distributing tobacco products, as defined herein, shall verify the age of the purchaser by means of a valid government-issued photographic identification containing the bearer's date of birth that the purchaser is 21 years old or older was born prior to 1/1/2000.

### In The Courts' Words:

- It [NFG] thus "augments" the protection against smoking-related illnesses ... beyond where the Legislature was willing to go, but where the Legislature expressly has invited cities and towns to go, if they so desire. Judge Davis, Superior Court (10/17/22)
- "State laws and local ordinances and bylaws can and often do exist side by side ...
  [and] this is particularly true of local ordinances and bylaws regulating public
  health, the importance of which we have long acknowledged." "Among these local
  powers no one is more important than that for the preservation of the public health."
  Supreme Judicial Court (3/8/24)
- "Because the bylaw falls within the type of local law limiting or prohibiting the sale of tobacco products expressly permitted by the act, and because the bylaw is not otherwise inconsistent, contrary, or conflicting with the act's minimum age standard, we conclude that it is not preempted. Supreme Judicial Court (3/8/24)

The Malden Board of Health will be conducting a Public Hearing on April 24, 2024, 6:30 PM, at Malden City Council Chambers, 215 Pleasant St, First Floor on Amendments to Section 21 of the Board of Health Rules and Regulations, Nicotine Delivery Systems, relative to;

"Prohibition of Sales – No person, firm, corporation, establishment, or agency shall sell tobacco or e-cigarette products to anyone born on or after 1/1/2004.

Any person, firm, corporation, establishment, or agency who or which shall violate any provisions of this regulation and upon written notification shall be fined and suspended in accordance to the schedule set forth under the Regulation of the Malden Board of Health Restricting the Sale of Tobacco Products."
