

OACDL DUI Seminar BIOGRAPHIES

The Honorable Michelle D. Earley

Michelle D. Earley was appointed to the Cleveland Municipal Court on April 20, 2009 and was elected the following November. By a unanimous vote of the Judges in December of 2017, she became Administrative and Presiding Judge. Judge Earley attended The Ohio State University and received a Bachelor of Science degree in Business Administration with a concentration in Information Systems. She received her JD from Case Western Reserve University School of Law. Judge Early was appointed to the Commission on the Rules of Superintendence for Ohio Courts in 2012 and reappointed in 2015. She was also selected to serve on the Ohio Supreme Court's Grand Jury Task Force. She currently serves on the Case Western Reserve University School of Law's Diversity Committee. Additionally, she has completed coursework to become an Advanced Science and Technology Adjudication Resource Program (ASTAR) Fellow.

Robert G. Walton

Robert Walton received his JD from Cleveland-Marshall College of Law. He has successfully defended clients in many jury trials on charges ranging from murder to OVI. He has cross-examined police officers during more than 200 suppression hearings. For the past 20 years, the focus of his practice has been on alcohol and drug related vehicular offenses. Mr. Walton has served as an acting judge in the Shaker Heights Municipal Court since 1995. Since 2005, he has been the magistrate for the City of University Heights Juvenile Diversion Program. His work in that program and his involvement in community based girls and boys basketball program, resulted in him being named the University Heights Citizen of the Year in 2013. Mr. Walton and Judge Deborah Nicastro are the authors of the Ohio Driver's License Suspensions and Reinstatement Handbook, the Fifth Edition of which was published in September, 2017.

Joe Hada

Joseph Hada, Attorney for Quinn Legal Associates, has dedicated his practice to OVI/DUI, Criminal and Traffic Defense. As a former public defender, Mr. Hada has a wealth of experience in defending OVI/DUI, Criminal and Traffic charges from arraignment through trial and on to appellate argument. He has shared his expertise as a speaker at OVI seminars across Ohio on a variety of topics and is dedicated to remaining on the forefront of OVI defense issues in Ohio. He regularly attends advanced DUI Defense training and seminars regarding Standardized Field Sobriety Testing, Advanced Roadside Impaired Driving Enforcement, Forensic Chromatography, Breath, Blood and Urine Testing, and trial tactics.

Ken Bossin

Kenneth Bossin is a private practitioner in Cleveland. He is a graduate of the University of Missouri, and received his Juris Doctorate degree from the Marshall College of Law at Cleveland State University. He is certified by the National Highway Traffic Safety Administration on Standard Field Sobriety Testing. He has served as an expert regarding Field Sobriety Testing in Aggravated Homicide and other OVI cases. Mr. Bossin served on the Traffic Law Subcommittee of the Ohio Sentencing Commission and the Traffic Law Committee of the Cuyahoga County Bar Association.

Jon Saia

Jon Saia has over 30 years of experience in defending OVI cases. The focus of his practice is OVI defense. Beyond representing individuals charged with OVI, he also provides consultation and expert testimony on the issue of field sobriety testing and is often consulted by colleagues with regard to breath testing issues. The National Highway Traffic Safety Administration (NHTSA) and the International Association of Chiefs of Police (IACP) have certified Mr. Saia as an Instructor in DUI Detection and Standardized Field Sobriety Testing. In addition, the National Patent Analytical Systems, Inc. (the manufacturer of the BAC Datamaster) has certified Mr. Saia in the operation, diagnostic verification and calibration of the BAC Datamaster Breath Alcohol Testing Instrument, the most commonly used breath testing instrument in Ohio. Recently, Mr. Saia completed training in the operation of the Intoxilyzer 8000 Breath Alcohol Testing Instrument. With blood alcohol testing becoming more prevalent in Ohio, Mr. Saia completed a course in Gas Chromatography and Metrology in order to better defend his clients. Mr. Saia has also completed the NHTSA and IACP sponsored Drug Evaluation and Classification Program in light of Ohio's relatively new Driving Under the Influence of Drugs (DUID) laws. In addition to speaking at seminars, Mr. Saia participates in approximately 40 hours per year of continuing legal education, both locally and nationally, regarding DUI defense.

T. Douglas Clifford

Mr. Clifford received his JD from Case Western Reserve Law school in 2001. His undergraduate degree is from Kent State University in "Applied Conflict Management." Mr. Clifford's career started as an assistant Huron County Public Defender. In 2007 Mr. Clifford became the Assistant Law Director for the city of Norwalk, prosecuting misdemeanor cases and handling preliminary hearings for the majority of Huron County. In 2012 Mr. Clifford came back into private practice, focusing on Criminal and OVI/DUI defense, as well as serving the Huron County Public Defender's Office in a part time capacity handling misdemeanor criminal cases and all OVI related offenses for the Huron County Public Defender's Office. Mr. Clifford is both a board member and currently a co-chair of the CLE program of the Ohio Assoc. of Criminal Defense Lawyers (OACDL), a founding member and State Ambassador of the DUI Defense Lawyers Assoc. (DUIDLA), a general member of the National College for DUI Defense (NCDD), an associate member of the American Academy of Forensic Sciences (AAFS),

and a member of the American Chemical Society Chemistry and the Law Division (ACS-CHAL). Mr. Clifford has recently achieved the designation of "Lawyer-Scientist", the highest level of honor available to a lawyer by ACS-CHAL. Doug has attended numerous national and state seminars. In 2016 Doug co-presented with Heather L. Harris, MFS, JD, D-ABC at the annual AAFS Annual Scientific meeting (Jurisprudence Section) on the topic of "The Legal and Scientific Landscape of Federal Analogue Prosecutions Post-McFadden." He has been trained under the NHTSA Standardized Field Sobriety Testing protocol. Doug has also presented at many seminars throughout the state of Ohio on OVI defense and other topic areas in criminal law.

Andrew Bucher

Mr. Bucher's formal education sets him apart from other OVI defense attorneys. He has a BSPS (Bachelors of Science in Pharmaceutical Sciences) from the University of Toledo College of Pharmacy, and a BBA (Bachelors of Business Administration) from the University of Toledo School of Business. Mr. Bucher received his J.D. from the University of Toledo College of Law. He has briefed and argued before the Ohio Supreme Court, conducted jury trials in Felony and Misdemeanor Matters. Mr. Bucher is NHTSA certified to administer Standardized Field Sobriety Testing.

Blaise Katter

Since graduating from Ohio State Moritz Law School in 2014, Mr. Katter worked for the General Assembly as a Staff Attorney for the Ohio Criminal Justice Recodification Committee, a 24 person committee created by the legislature to re-write the criminal code - Title 29. As Staff Attorney for the Recodification Committee, he worked with the legislators, judges, prosecutors, and defense lawyers to study, examine, and significantly rewrite the criminal code. His work with the committee eventually culminated in the adoption of a 4000-plus page bill draft approved by the Committee as a recommendation to the General Assembly. Mr. Katter and the other Staff Attorney also compiled a (much shorter) summary of the significant changes to each section and the rationale for these changes. Mr. Katter has now transitioned into private practice and works for Tim Huey as a defense lawyer in Columbus.

D. Timothy Huey

Tim Huey is a Columbus Ohio DUI lawyer who has a statewide and national reputation as a DUI Defense Lawyer. Huey led the team that destroyed the Intoxilyzer 8000 in State v. Lancaster and State v. Jerome. In State v. Ilg he helped convince the Ohio Supreme Court that accused citizens have a right to challenge their breath test results. Huey's passion for his profession has led him to serve as President of the Ohio Association of Criminal Defense Lawyers (2012) and recognition by the National College for DUI Defense and other organizations. He serves on the Teaching Faculty for the NCDD's annual session held at Harvard University. The national DUI Defense Lawyers Association (DUIDLA) invited him to be a Charter Member and a Trustee for their Justice Foundation. He has given over 75 presentations on DUI defense for organizations around the country.
