BIOGRAPHIES

David Hejmanowski

David A. Hejmanowski has been a juvenile and probate court magistrate for Delaware County since January of 2003. Prior to this, he served as an assistant prosecuting attorney for Delaware County, handling more than 400 felony cases. He graduated as a Public Service Fellow from the Ohio State University Moritz College of Law in 1999 where he also received the Joseph M. Harter Memorial Award. He received his B.S. in political science from Hiram College in 1996. He was appointed in 2005 by Chief Justice Moyer to the Supreme Court Advisory Committee on Interpreter Services. He is the Attorney Coordinator for the Delaware County Interfaith Legal Services Clinic and a member and past secretary of the Ohio State Bar Association Juvenile Justice Committee. He is a frequent presenter for the Ohio Judicial College. David and his wife Ashley and their two children, Catherine and Nicholas, reside in Delaware.

Marcia Fisher

Marcia is a graduate of Central Michigan and Wilberforce Universities with a Master's Degree in Human Resources Administration, and a Bachelor's Degree in Organizational Management. She has worked for the Department of Public Safety for 6 years, and has 23 years of experience in public service. As the Supervisor of the Alum Creek Office she plans and directs the operations of all license reinstatement activity. She provides training to legal representatives, law enforcement agencies, courts, and judges on the reinstatement process. Marcia has received recognition for her participation in several successful community outreach efforts which have included the Safe Surrender program in Franklin and Richland Counties.

Judge Joan Synenberg

Judge Synenberg was elected to the Cuyahoga County Court of Common Pleas and began her service in January 2007. Before assuming her seat in the Court of Common Pleas, she served as a Cleveland Municipal Court Judge from 2005 to 2007. Before assuming the bench Judge Synenberg engaged in an active criminal and civil trial practice for 16 years after graduating from the Cleveland-Marshall College of Law. In 2009, she was honored with the Cleveland-Marshall College of Law Outstanding Alumna Award. Since 2009, Judge Synenberg has served as the Eighth District Chair of the Ohio State Bar Association Pro Bono Task Force. Under Judge Synenberg's leadership, hundreds of lawyers have participated in complimentary continuing legal education (CLE) courses in exchange for donating their legal services to a person in need. Free advice clinics on civil matters, criminal matters and foreclosure are held all year throughout the community, and the effort is annually celebrated during National Pro Bono Week.

Pam received her JD from Georgetown University in 1978. After graduation, she worked as an associate attorney for 5 years for Reed, Smith, Shaw & McClay. Pam moved to Columbus in 1985 and started working for Squire, Saunders & Dempsey, LLP and resolved disputes involving public and private contracts, investor claims, trade secrets, intellectual property and antitrust laws. Pam joined OJPC in March, 2010 to perform legal research for the Collateral Sanctions Database Project.
