



## **Ohio ACEP Board of Directors & Councillor Candidates**

### **Board Elections**

Board members will be elected by ballot by majority vote of the Chapter membership at the Chapter's [Virtual Annual Meeting](#) on **June 8, 2021**.

Their terms of office will begin at the close of the Annual Meeting at which they are elected. There are 15 members of the Ohio ACEP Board.

**Seven (7) Board Members will be elected by the membership to serve a three-year term.** Current Board members with expiring terms are eligible for re-nomination and re-election.

### **Councillor Elections**

Councillors will be elected by ballot by majority vote of the Chapter membership at the Chapter's [Virtual Annual Meeting](#) on **June 8, 2021**.

[ACEP Council](#) is the deliberative and representative body that meets once a year for two days prior to the College's annual Scientific Assembly (2021's Scientific Assembly, ACEP21, is planned to be held in Boston, MA on Oct 23 & 24, 2021). The Council votes on resolutions, elects members to the National ACEP Board of Directors, and ensures grassroots involvement in the democratic decision-making process.

**Ten (10) Councillors will be elected by Ohio ACEP membership to serve a two-year term.** All current Councillors with expiring terms are eligible for re-nomination and re-election.

## Board Candidates

### **B. Bryan Graham, DO, FACEP; Board Candidate**

*Incumbent (Hudson, Ohio)*

Dr. Bryan Graham is an emergency medicine physician at the Cleveland Clinic, practicing at the Main Campus and Fairview Hospital. He also serves as an enterprise physician advisor for the health system, is the physician lead for the reimbursement and denial initiatives within the Emergency Services Institute and leads the virtual program for the ED. Dr. Graham currently serves as Secretary on the executive committee of Ohio ACEP's Board of Directors. He is also an Ohio ACEP Councillor.

In his role within Ohio ACEP, Dr. Graham has led the advocacy efforts around the surprise medical billing legislation that was recently passed, leveraging his expertise gained from graduating the inaugural ACEP Reimbursement and Leadership Development Program. He also serves on multiple national committees and tasks forces related to Reimbursement and Advocacy, including the ACEP Reimbursement Committee, the Coding and Nomenclature Committee, the ACEP Telehealth Task Force, and the ACEP/EDPMA Task Force on Surprise Medical Billing. He was also recently nominated to serve as the alternate advisor for the ACEP RUC team.

Dr. Graham believes having continued expertise on reimbursement related issues at the Ohio ACEP Board level will be critical moving forward, especially given the advocacy lift needed for the rule making process regarding surprise medical billing, balancing state legislation with new federal language, broad adoption of virtual emergency medicine care delivery and supporting the introduction of the new enhanced prudent layperson language. He looks forward to continuing to support Ohio ACEP and its members as it navigates a pivotal time in emergency medicine.



### **Bradley Raetzke, MD, MBA, FACEP; Board Candidate**

*Incumbent (Upper Arlington, Ohio)*

Dr. Bradley Raetzke is a board-certified emergency physician practicing at several hospital campuses in Columbus, Ohio. He is also the Assistant Medical Director of Emergency Services at Riverside Methodist Hospital and serves as Medical Director for several EMS agencies.

Dr. Raetzke is the current Past President of Ohio ACEP and has served on the Ohio ACEP Board for the past seven years. He previously served the Chapter as Co-Chairman of the Government Affairs Committee and currently serves as Chair of the EMS Committee.

Looking forward, he hopes to continue pushing for physician advocacy at both the state and national level, in addition to ensuring the Chapter conducts business in a fiscally responsible manner. ### **Christina Campana, DO, FACEP; Council Candidate**

*Incumbent (Richfield, Ohio)*

Dr. Christina Campana currently serves as Associate Professor of Emergency Medicine at Northeast Ohio Medical University (NEOMED), and is a board-certified physician and core faculty member for the Emergency medicine residency at Cleveland Clinic Akron General in Akron, Ohio. She is also the EMS Medical Director for Coventry Fire Department in Summit County.

In addition to the above leadership roles, she is a 2018 graduate of Ohio ACEP's Leadership Development Academy and has served on the Ohio ACEP Chapter Council since 2017. She has been an ACEP and Ohio ACEP member since 2009 when she began her residency at Akron General.

Dr. Campana has been active in education and research, and has several publications in peer-reviewed journals in emergency medicine. She has been involved in government affairs with Ohio ACEP, working with the chapter through LDA in educating legislators locally and on Capitol Hill. As a pediatric emergency medicine physician, she understands the unique aspects of pediatric care and enthusiastically represents that niche. Her passion has led to many meaningful changes regarding care of Behavioral Health patients and she is considered a content expert in that field.

She is a graduate from the Executive MBA program from Case and is applying those skills to further the organizational efforts to streamline and manage care. Her leadership and advocacy efforts have stemmed from local, state and national involvement. ### **Catherine Marco, MD, FACEP; Council Candidate**

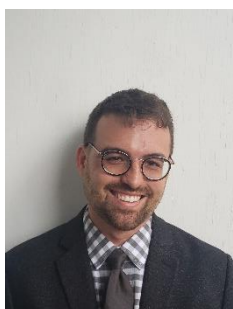
*Incumbent (Beavercreek, Ohio)*

Dr. Catherine Marco currently serves as Professor of Emergency Medicine at Wright State University and is an attending physician at Miami Valley Hospital in Dayton, Ohio.

Dr. Marco has served as a Councillor representing the Ohio Chapter since 2004, sat on the Ohio ACEP Board of Directors from 2001 to 2012, and was Chapter President from 2006 to 2007. She has been a member of the National ACEP Ethics Committee since 1997 and chaired the Committee from 2011 to 2013.

Dr. Marco has been active in the education, research, and writing arenas. She has published numerous research manuscripts and book chapters on medical ethics, resuscitation, dermatology, airway, and pain management.

Dr. Marco would be pleased to continue to represent and support Ohio emergency medicine physicians as a Councillor on the American College of Emergency Physicians Council.



### **Ryan Marino, MD; Council Candidate**

*(Cleveland, Ohio)*

Dr. Ryan Marino was born and raised in Northeast Ohio (Chagrin Falls), and after obtaining an undergraduate degree at the University of California Los Angeles, completed medical school, emergency medicine residency and medical toxicology fellowship at the University of Pittsburgh. Returning to Ohio in 2019, he has worked as an attending Emergency Medicine physician at University Hospitals Health System where he founded the divisions of medical toxicology and addiction medicine. He also serves as the medical director for an addiction medicine bridge clinic that he launched and covers calls for the Cincinnati Children's Drug & Poison Information Center.

Dr. Marino is active in policy discussions both locally and nationally on topics related to emergency medicine and medical toxicology, and has been active with ACEP at the national level where he authored a position statement endorsed by ACEP, "Remove the Waiver Requirement for Prescribing Buprenorphine for Opioid Use Disorder," and assisted with other advocacy efforts for emergency physicians and our patients. He has worked with local, state and national politicians and policymakers and has many contacts in both health and policy.

Dr. Marino hopes to bring expertise on substance use and addiction, patient and physician advocacy, and to further the practice of emergency medicine in Ohio. He understands that the practice of medicine is undergoing dramatic changes, and our specialty, in particular, faces many challenges in the near future. **Daniel Martin, MD, MBA, FACEP; Council Candidate**

*Incumbent (Westerville, Ohio)*

Dr. Daniel Martin is Professor and Vice Chair of Education at The Ohio State University College of Medicine. He is the former Program Director of the Categorical Emergency Medicine Residency Program and current Program Director of the Emergency Medicine Internal Medicine Combined Residency.

Having served on ACEP Council for over 20 years, Dr. Martin has helped support and write resolutions and has been engaged in nearly all Council activities. He is proud, honored and humbled to participate in the annual ACEP Council Meeting. Whether mentoring junior Councillors or speaking on the Council floor, Dr. Martin is compelled to be fully engaged in fairly representing his colleagues with effort and integrity.

*Incumbent (Chardon, Ohio)*

Dr. John Queen has been both an ACEP and Ohio ACEP member since 1999 and has served as an Ohio Chapter Councillor and as a Board member since 2011. He presided as Chapter President in 2018.

One of Dr. Queen's greatest passions is for the education of future physicians in emergency medicine. An established leader in emergency medicine resident education, Dr. Queen has served as an Assistant Residency Program Director since 2003 and as Course Director of the Ohio ACEP Oral Board Review Course from 2008-2019. Dr. Queen's greatest honor was winning the 2006 Teacher of the Year Award at Cleveland Clinic for his work with the emergency medicine residents.

### **Ryan Squier, MD, FACEP; Council Candidate**

*Incumbent (Powell, Ohio)*

Dr. Ryan Squier was born in Toledo, Ohio, graduated from St. John's Jesuit High School and pursued a Bachelor of Science in Biology degree from Loyola University of Chicago. While studying at Loyola, Dr. Squier earned minors in Bioethics and Business Administration. He then returned to Toledo to attend the University of Toledo College of Medicine for his medical degree. Dr. Squier met his wife while on a medical mission trip in Nicaragua (her in nursing school and Dr. Squier in the midst of medical school). Seeking to continue training for emergency medicine in arguably the most beneficial climate for the specialty, Dr. Squier stayed in Ohio and trained at Akron General Medical Center, the first community-based emergency medicine residency program in the country.

Through this experience, Dr. Squier has had the opportunity to learn and interact with many of our state and national leaders and he hopes that he, too, may enact a further sense of leadership for an organization that supports our specialty of emergency medicine.

As an Ohio ACEP member, Dr. Squier has helped to further EM's voice to the community about the opioid abuse epidemic that plagues our society, serving as project coordinator for NIX Opiates, a grant-sponsored program for Ohio High School students and parents. ### **Eileen Baker, MD, PhD, FACEP; Board and Council Candidate**

*Incumbent (Bowling Green, Ohio)*

Dr. Eileen Baker has worked as a community emergency physician since 2001 and moved to Bowling Green, Ohio, to pursue her PhD in Applied Philosophy at Bowling Green State University.

She has been an active member of the American College of Emergency Physicians since medical school, serving National ACEP on the Continuing Education, EMS, Reference, Ethics and Tellers Committees. Dr. Baker began her commitment to Ohio ACEP in 2004. She has co-chaired the EMS Committee and been involved with the Education and Government Affairs Committees. He currently serves as Treasurer on the Ohio ACEP Executive Committee while completing his second Board term and has held a position of Councillor for six years. Previously, he served as President of the Medical Staff for Marietta Memorial and Selby General Hospitals, as a Core Faculty Member for the Emergency Medicine Residency Program, as the Medical
