The Summer Camp presentations include:

- **A "Deep Dive" Session on Medicare Regulations and Policies**  
Complex, ever-changing Medicare rules are a persistent challenge for HME suppliers. With audits, face-to-face, Medicare bidding, bid rate expansion and more on our heels, it's crucial that your organization have the latest insight on federal regulations. Kim understands the HME world as a former provider prior to joining the national association. She knows what you face on a daily basis, and she's passionately tackling our national regulatory issues before CMS. Join us as Kim breaks down the details, provides the latest on current and upcoming regulatory issues, and shares insight on her on-going meetings with CMS.
- **It's "Go" Time for the ICD-10 Transition – Are You Ready?**  
October 1 is a "go" for the transition and you need to be prepared for this major change. This session will provide insight to help make sure that your organization is on track and begin the assessment of referral source readiness. The timely presentation will show you how to develop risk-mitigation strategies to minimize transition problems and maximize opportunities for a successful transition to ensure that your company, your processes and your IT system are ready to go when the switch flips in five months!
- **ICD-10 Update by Ohio Medicaid** This change involves all of your payment sources, not just your Medicare claims, and the Ohio Department of Medicaid has been preparing for the October 1 ICD-10 transition as well. This session will provide a brief update by the state agency staff with the current readiness of the State program and provide resources for important on-going information before, during and after the transition.
- **Jurisdiction B DME MAC Update** Outreach staff from National Government Services will update us on the latest news from the Medicare contractor. We'll cover the Medical Director's annual LCD updates, news on documentation rules under the ACA including face-to-face and WOPD, proof of delivery, date stamps, and ICD-10 implementation. We'll also review self-service tools and the latest on the Educational Review Request (ERR) program.
- **Breakthrough Strategies for Educating Referral Sources on DME Rules Requirements** Obtaining sufficient clinical documentation and staying abreast of constantly changing regulations is a significant burden on everyone in the care coordination continuum to Medicare beneficiaries. The fast pace of change coupled with tedious HME-unique details makes it challenging to communicate to referral sources while they balance other obligations of their job. We've developed a new presentation aimed at helping HME providers educate their referral sources to improve the efficiencies of processing DME documentation requirements. This is a don't-miss session for your Medicare billing staff!
