She leads the development of the role of HME providers in care management models and advocates for strong networks that offer patients choice and quality care while protecting appropriate reimbursement and fair policies. She will share work being done with non-Medicare payers to minimize adverse effects and maximize benefits and will outline AAHomecare's initiatives to benefit HME providers in our states.

When Gov. Mike DeWine took office in early 2019, he called on Ohio's Medicaid agency to ensure Ohioans get the best value in providing quality care. In response, the agency engaged the public in a statewide outreach to develop "a bold, new vision" for the Medicaid program, "one that focuses on people and not just the business of managed care". Managed care procurement, along with many other "Next Generation" program changes, are underway to strengthen the structure of Ohio's \$20 billion managed care program; the first since CMS' approval of Ohio's program in 2005. We're honored to welcome the agency's top official to provide an update on these transformative activities in Ohio's Medicaid program.
