 OAMES and the ODM Policy team work routinely and collaboratively on Medicaid HME policies. Ohio requires all state
 agencies to review their rules at least every five years and 2023 marks the year that many HME rules hit this requirement.
 We'll hear from Mark regarding all of the rules projects currently underway and highlights of the coming policy changes.

In 2009, the Ohio Health Information Partnership was founded which led to the development of CliniSync, a health information exchange. Their mission is to improve care for all Ohioans by facilitating the exchange of health and other critical information. The non-profit organization is exploring opportunities with Ohio Medicaid managed care plans to capture and share data from continuous glucose monitoring systems (CGMs) to improve patient outcomes. #### 2:30 pm – Ohio's Next Generation Managed Care Program is Here! Where We Are and What's Next?

Jim Tassie, Deputy Director – Ohio Department of Medicaid

Three years ago, the Ohio Department of Medicaid launched the Medicaid Managed Care Procurement process with a "bold, new vision for Ohio's Medicaid program – one that focuses on people and not just the business of managed care".

This is the first structural change since CMS' approval of Ohio's program in 2005. ODM is currently rolling out its Next Generation managed care program with stage 1 OhioRISE launched on July 1 and stage 2 and 3 launching this fall culminating with the implementation of the Next Generation MCOs on December 1. Jim Tassie is leading the ODM team on this endeavor and will join us to share the latest details about the roll-out and steps in the weeks ahead.
