Applicants **must** meet the following criteria to be eligible:

1. MEMBER of the Ohio Fire Chiefs' Association serving in a career, combination, or volunteer department;
2. Work in a county in OOGEEP's defined territory (See page 3 of this application for the list of counties);
3. Commitment to register for either a Full Conference package or Weekend Conference package;
4. Commitment to actively participate in one OFCA committee during the 2020 – 2021 year;
5. Hotel reservations will be made for Thursday, July 16 – Monday, July 20, 2020 for Full Conference packages and Saturday, July 18 – Monday, July 20, 2020 for Weekend Conference packages.

Preference will be given to First Time Conference attendees and departments showing financial hardships.

Upon notification of being selected for an OOGEEP Scholarship, the recipient will be required to pay a Conference registration fee of \$200.00, which will be reimbursed to the recipient after attending the Conference.
