



Documentation: TSA (Transportation Security Administration) require your airline ticket to match what ever ID you will be using for travel. Your name must appear on your airline ticket exactly as it appears on your travel identification i.e. Passport, Driver's License or State Issued Identification Card with a Birth Certificate. TSA can deny boarding if they do not match exactly. **You do not need a passport for the U S Virgin Islands, but it is HIGHLY recommended that you carry one.**

Deposit and Final Payment: An initial deposit of \$500.00 per person with the optional insurance plus the CEU fees are due at time of booking. Final payment is due on or before November 28, 2014.

Cancellation: Cancellations made after initial deposit will be subject to a cancellation handling fee of \$100.00 per person. Cancellations made after November 28, 2014 are nonrefundable.

Cancellation Insurance: World of Travel strongly suggest you take trip medical cancellation, travel delay, trip interruption, and baggage insurance. If you have a medical condition which does not allow you to travel at the time of your registration, the insurance policy may not cover you. Insurance cover most pre-existing conditions but, if you have or think you might have a pre-existing condition, we highly recommend you call Travelex to confirm if you would be covered in the event of cancellation. In order to qualify for the "pre-existing condition" waiver, you must purchase the insurance within 14 days of making your deposit. We recommend sending in your insurance payment with your initial deposit. Should it become necessary for you to cancel or interrupt your trip because of a covered unforeseen medical problem, baggage or trip interruption, of your own, your roommate, your spouse or an immediate family member, a claim will be filed with Travelex Insurance Company.
