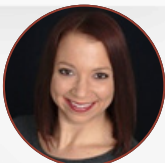
Thom Arnold, DPM

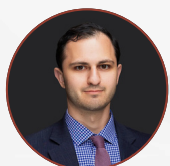
Bryan Markinson, DPM
