

## OHLA Emerging Professionals Education & Training Fund Application Eligibility Guidelines for 2022 Annual Conference on November 21-22, 2022

SECTION 1: PERSONAL INFORMATION

(Please print or type)

The Ohio Hotel & Lodging Association Education & Training Fund (ETF) is open to qualified Emerging Professionals attending the the Annual Conference as an *Additional Attendee* from their property. Nothing in this application requires the awarding of any education or training dollars.

- To be considered for funds, you must be an employee at a current OHLA Member property before submitting an application. A Director of Sales, General Manager or equivalent must be registered for the conference from the same property.
- The funds must be used for attending the full 2022 Annual Conference educational sessions, not just the Gala Dinner.
- Qualifying Experience: Has spent no more than three years, collectively, working at an Ohio Lodging property. Current employment must be with an OHLA Member hotel to qualify.
- Maximum of two total scholarship earning additional attendees per property. This applies across all scholarships.

## **Application Process**

The following material must be submitted to the committee:

A) A completed and signed ETF application. Only complete applications will be considered.

B) An essay of no more than 500 words describing why you would like to attend the OHLA Annual Conference and how you will prepare.

Include answers to the following questions:

- What are your career goals?
- How will this program help you to achieve your career objectives and future goals?
- What suggestions do you have for topics at conference?
