# 404: "First, Do No Harm" Verbal De-Escalation and Crisis Intervention: Practical Approaches and Skills (Human Resources Track)

Given the nature of county programs, it is not unusual to encounter an individual seeking help who finds themself in crisis. In this session participants will:

- Learn about crisis risk factors, the four primary phases of a crisis, and how to recognize the signs that a person is in or about to be in crisis.
- Understand which verbal de-escalation techniques are (and are not) effective within each phase.
- Be taught pre-crisis preparation actions that can prevent escalation, including the five high level intervention approaches.
- Learn effective verbal and non-verbal methods to discern what a person in crisis needs in order to return to baseline mood and behavior.
- Gain basic understanding of how the "crisis brain" and a person's history related to trauma and other common factors may impact self-regulation.
- Explore and better understand their own physical and emotional response to working with those in crisis.

The Benefit Bridge program currently being piloted in ten counties is designed to help individuals gain support, life skills, training, work, and an experience that will help them cross over to self-sufficiency helping to end dependance on public assistance. The program also addresses the "benefit cliff" individuals face when tapering off or ending public assistance benefits due to a household or an individual's increased earnings.
