## **Education Update**

Education Committee- Meredith Marsh - Chairwomen

\*\*\*The City of OKC is still ironing out details with the rules and the portal. ORCA felt it was important to get information to our Roofing Contractors ASAP \*\*\*

The permit process will be similar to building contractor licensing, it will require the following:

Register company with the City of OKC as a contractor (potentially a new category of roofing contractor)
 Obtain Required Documents:

General liability insurance (minimum of \$500,000 for each occurrence)

Workers compensation exempt form (if applicable)

Workers compensation (minimum of \$100,000 for each occurrence

General Liability requirements for Commercial Endorsement \$100,000

Immigration affidavit (if applicable)

Payment \$100 (Could be another amount TBD)

- 2. Request a permit for re-roofing & pay fee (TBD)
- 3. Post Permit before starting work
- 4. Submit before, during and after pictures / video to City of OKC portal reviewed by inspector.
- 5. Obtain approval of inspection on re-roofs

## **Legislative Update**

On May 27th, the 58th session of the Oklahoma State Legislature formally adjourned Sine Die. The Legislature met its constitutional deadline of May 28th.

Governor Kevin Stitt signed additional legislation into law today as part of the Fiscal Year 2022 state budget package, including House Bill 2900, the general appropriations bill. The FY 2022 budget cuts taxes for all Oklahomans, invests a record \$3.2 billion in education and replenishes over \$800 million in state reserve funds that were significantly reduced to offset pandemic-related revenue reductions last year for a record \$1.3 billion in savings for the state of Oklahoma.

#### Highlights include:

- ■Increases common education funding by \$171.6 million, or 6%, to a record high of nearly \$3.2 billion.
- Replenishes state savings account by more than \$800 million to a total of \$1.3 billion a record among of savings for Oklahoma.
- Funds expanded Medicaid for low-income Oklahomans.

The Governor also signed HB 2895 which apportions \$80 million to the Rebuilding Oklahoma

Access and Driver Safety (ROADS) Fund; HB 2951 which creates the State- Tribal Litigation

Fund; HB 2961 which reduces the tax rate paid by banking associations and credit unions; SB

608 which creates a new film tax incentive to attract and recruit more film industry projects; and

HB 2946 which expands broadband in underserved and unserved areas statewide through a \$42 million tax incentive for providers.

Last week Governor Stitt signed legislation as part of the comprehensive budget agreement between the House and the Senate, including an individual income tax cut and corporate income tax cut. The budget was built on the Board of Equalization¶s February certification of \$9.6 billion in revenue available for appropriations. Of that figure, the agreement spends \$9.06 billion and allocates the rest to tax relief, replenishing reserves, or replenishing off-the-top funding temporarily redirected during the pandemic last session.

Finally, ORCA's legislation failed to reach the Governor's desk for his signature. Both the Deductible and Labor Only Crew bills ran into opposition from various sides once they reached the Senate Business committee. All sides have agreed to work together through the issues in the interim and get these issues resolved before the 2022 legislative session.

#### Failure to Comply to Inspections

Cathedral City, CA. A worker was crushed from a metal gate on a loading dock, crushing a 41-year-old construction worker. This incident was fatal and could have been prevented.

Occupational Safety and Health Administration investigation that followed the Dec. 7, 2020, tragedy found that the Penta Building Group, No Limit Steel and The Raymond Group – failed to conduct inspections to discover and recognize any workplace hazards. Al three contractors face \$64,169 in combined fines.

How does this effect a Roofing Contractor and Sub-Contractors? What this is saying OSHA can and will site everyone involved in an incident. If you fail to provide safety or inspections to eliminate hazards, you as a contractor can be deemed at fault. You as a contractor are responsible for providing and or verifying that training and inspections are completed and done to OSHA standards.

We must understand that as contractors/general contractors we must follow all OSHA standards and must provide a safe workplace environment free of recognized hazards. We must be aware and understand that OSHA does not care what your contract with a sub-contractor says. You as a general contractor must make sure your sites are following OSHA standards and are your sub-contractors doing inspections, training and are you making sure they are following all the standards.

We in the roofing industry are under the microscope when it comes to OSHA. We are the first to be seen by the public and are easily seen. We need to set the standard, not be the standard. With help from ORCA, we are trying to help set the right standards in our community and set them higher then anywhere else.
