AN OVERVIEW OF MENTAL HEALTH DISORDERS: THE PHARMACIST'S ROLE IN OPTIMIZING CARE AND REDUCING STIGMA

Mental health disorders range from depression and anxiety to bipolar and psychotic disorders, and these disorders are strongly related to the occurrence and successful treatment of many chronic diseases, including diabetes, cancer and cardiovascular disease. Yet the stigma associated with mental health disorders often causes needless suffering, potentially causing a patient to deny symptoms, delay treatment and have poorer clinical outcomes. This session will help provide a better understanding of caring for patients with mental health disorders, and how pharma-

cists can reduce the stigma surrounding mental health and reduce barriers for those seeking or receiving treatment for mental illness.

PAIN MANAGEMENT: A PRIMER FOR PHARMACISTS

Pharmacists may begin to find themselves more involved in pain management in light of the current opioid epidemic. This session will provide a brief overview of the current Ohio guidelines for opioid prescribing, how to differentiate between different types of pain by using assessment skills, and development of treatment recommendations. Depending on the type of pain, opioids may not be the best choice. Opioid-sparing options such as anti-epileptics, gabapentinoids, and anti-depressants will also be explored. The aim of this presentation is to equip pharmacists to be more active participants in pain management in both community and hospital settings.
