The profession of pharmacy in Ohio is making great progress, and I am more excited about the actions that your association and foundation are planning than any time in my 23-year history with the Ohio Pharmacists Association (OPA) and Ohio Pharmacists Foundation (OPF)! The OPA brought together Ohio pharmacists from all types of practices and organizations to pass the immunization legislation,

while the OPF created the continuous training and updates that brought the legislation to life. Medication therapy management (MTM) has made huge strides forward, with more than 60 pharmacists meeting regularly to discover how to implement and improve these clinical services in our independent, chain, and various other pharmacy settings. By *Building Ohio Pharmacy's Future*, we are building upon a vision – a vision that pharmacists have unique talents to enhance patient care. The OPA and OPF have been engaged in many collaborative efforts in the past few years with other professions and various patient organizations, but have always had to meet with them in outside facilities, due to a lack of space. The new headquarters has plenty of space for conducting those collaborative meetings, as well as space to meet our growing staff needs.

The building will not only serve as a home for pharmacy in Ohio, but the services we develop will also serve as an example for pharmacists across the country. At the *Center for Ohio Pharmacy*, all health care stakeholders will be part of the process to explore new prospects, enhance offerings, tackle challenges, address needs, and encourage cooperation among professions, all in an effort to bring the best health care to Ohio citizens. We plan to develop an Entrepreneurship Center that will train pharmacists in skills needed to own, manage, and operate pharmacies today and in the future.

The Ohio Pharmacists Association (OPA) and Ohio Pharmacists Foundation (OPF) have been doing phenomenal work on behalf of pharmacists for more than 132 years. All that hard work has presented an unprecedented opportunity to finally have a permanent home to continue our efforts for many years to come.

We truly hope you will join OPA and OPF in this momentous campaign to continue *Building Ohio Pharmacy's Future*.

Our History...


Organizations, like institutions, reflect the lengthened shadows of individuals. Ideas germinate in the minds of individuals; they come to fruition when the right individuals come along at the right time, and through the persuasive force of their ideals, others of like mind join to form a groundswell, which will not be denied.

So it was that in 1879 Lewis C. Hopp was able to convince the members of the Cleveland Pharmaceutical Association to send out letters urging the Ohio pharmacists to meet and form a "State Pharmaceutical Association."

One hundred individuals attended the first meeting and settled down to business immediately. Hopp was called upon to state the objective of a state association. He responded by observing that, "the purpose was to elevate the character of the pharmaceutical profession, by uniting the reputable druggists of the state in order to foster the education of those learning the art and thereby stimulate the talent of those engaged in pharmacy." Ultimately, the goal would be to restrict the sale of medicines by persons qualified for the practice of pharmacy.

His motion to form a state association passed unanimously, and with that the Ohio State Pharmaceutical Association was formed. Now known as the Ohio Pharmacists Association, the group is one of the largest and most successful state pharmacy associations in the country.

The Ohio Pharmacists Foundation (OPF) was created in 1992 to meet the educational needs of pharmacists, and to provide an avenue to study and provide new and unique pharmacist-driven health care services to the public. As such, the OPF provides educational training programs and supports the conduct of practice-oriented research that demonstrates the value of the pharmacist in enhancing the delivery of pharmacy care and the attainment of optimal patient outcomes. The foundation is recognized as a 501(c)3 nonprofit organization by the IRS, and contributions to the foundation are tax-deductible. The *Building Ohio Pharmacy's Future* campaign is being conducted by the Ohio Pharmacists Foundation.



Our Legacy of Achievement for Pharmacy

For 132 years, the Ohio Pharmacists Association has excelled in protecting, preserving, and enhancing the profession of pharmacy. The Mission of the Ohio Pharmacists Association is to *unite the profession of pharmacy, and encourage interprofessional relations while promoting public health through education, discussion, and legislation.*

Today, with more than 3,000 members, OPA has been the premier organization of pharmacists representing the profession of pharmacy in the state. For more than a century, OPA has been the leader of a variety of efforts to support patient care, combat disease, and develop pioneering ways to enhance health care.

With the creation of the Ohio Pharmacists Foundation in 1992, pharmacist-centered education was found to be one of the best and most efficient ways to address many public health needs. The foundation offers research grants, conducts educational programming, hosts forums, and develops student activities that teach and add to the knowledge base of current and future pharmacists to encourage innovation and meet patient needs.

OPA and OPF have accomplished much over the years, but here are just a few of the notable successes:

- In 1971 OPA was instrumental in expanding the Ohio State Board of Pharmacy to provide increased representation of those in various areas of pharmacy practice.
- In 1971 OPA pushed for the establishment of mandatory continuing education for Ohio pharmacists, the first profession to have such requisites written into law for the public interest.
- After data was released showing Ohio led the nation in pharmacy robberies, 1976 saw the passage of the “Ohio Pharmacists Declaration of Independence from Fear” law, which created strict mandatory sentencing for those convicted of the robbery of a pharmacy in Ohio.
- In early 1978 the repeal of Ohio’s anti-substitution laws took effect. This permitted pharmacists to substitute generically equivalent drugs for brand names without first obtaining permission from the physician. This was a major paradigm change at the time for pharmacy practice. OPA, then OSPA, prevailed over colossal opposition from the pharmaceutical manufacturers and the medical association over a three-year period.



- In 1984 OPA co-founded the Pharmacists Rehabilitation Organization, Inc. (PRO) to educate and inform the profession of pharmacy concerning chemical dependency as a treatable disease and to help pharmacists and student pharmacists find recovery from their active disease.


- 1998 saw the culmination of several years of work by the association to broaden the scope of pharmacists’ activities. OPA brought together representatives from the Board of Pharmacy, as well as other pharmacy organizations, to develop this essential pharmacy legislation. Consult agreements



allowing pharmacists to manage drug therapy were in the bill, as well as reference to many new drug therapy services provided by pharmacists. The legislation passed, and many positive changes followed in Ohio pharmacy.

- Legislation drafted by OPA, in cooperation with many pharmacy organizations, was adopted in 2000 allowing pharmacists to administer certain adult immunizations. The OPF proceeded to train hundreds of pharmacists through our educational workshops. This legislation was key to the pharmacist being seen by the public as a “hands-on” health professional, with individuals making appointments to see the pharmacist for the first time.

- The monthly member journal, *Ohio Pharmacist*, which also contains continuing education for pharmacists, has been the recipient of numerous industry awards for journalistic excellence and has been widely recognized as one of the leading pharmaceutical publications in the country.



- The OPA Annual Conference is known for providing high-quality continuing education and continually boasts the highest attendance rates in the country among state associations.



Pharmacy's Home in Columbus, Ohio

OPA and OPF's new, permanent home will be located in Ohio's capital – a perfect location in Central Ohio for protecting and enhancing the profession of pharmacy. It's easy to reach by members, just minutes from I-270 and Sawmill Road on the northwest side of the city.

Located at 2674 Federated Boulevard in Columbus, the new home for OPA and OPF was originally constructed in 1997. At just under 6,000 square feet, the facility boasts a welcoming exterior, 33 parking spaces, an elegant patio, a large meeting

room, beautiful green space, and an executive meeting room that will make pharmacists feel welcome. It is the ideal location for taking pharmacy into the future.

OPA and OPF have made plans to adapt the space to meet the needs of members and staff. Plans are already underway to construct offices, education areas, student and resident space, a large conference room, a pharmacy legacy brick path, and a new home for the *Wherry Pharmacy Heritage Museum*.



The Campaign for *Building Ohio Pharmacy's Future*

The plan is simple. For 132 years OPA and OPF have striven to fulfill and exceed the medication-related needs of patients and health care providers with pharmacist-based solutions. For the next few decades and beyond, we aim to continue and build upon our impact of health care issues. The new *Center for Ohio Pharmacy* will be the launchpad for our push into the future.

The *Center for Ohio Pharmacy* will provide a centralized location for training and education, community action, and research activities that are critical to the continued presence and effectiveness of pharmacists in the community. With the additional space, we will be able to provide specialized programs in immunization, compounding, disease and medication therapy management, technology, entrepreneurship, and marketing techniques that are currently unavailable elsewhere. Our intent is to provide unique training and education that will be immediately applicable in the pharmacist's practice.

The bottom line is that OPA and OPF have positioned themselves for tremendous growth and expansion. Our goal is to build on the successes of the past to create an even bigger and better future for Ohio Pharmacy.

While OPA and OPF have been good stewards of the members' money over the years, we are seeking help to reach our financial goals to fulfill a greater vision for the future. That is why, along with this building, there will be a comprehensive fundraising effort for *Building Ohio Pharmacy's Future* so that we can have the state-of-the-art facility our members deserve. There are numerous opportunities for pharmacists, friends of the profession, and pharmacy vendors to make their mark on what will be a permanent landmark for Ohio pharmacists for many years to come.

To compliment some of the luxurious outdoor space at this new facility, there will be bricks and benches that groups and individuals can stamp their names on.

Expanded Education and Outreach Centers

Center for Excellence in Pharmacist Continuing Education \$300,000

The Ohio Pharmacists Foundation (OPF) is known around the country for being one of the premier providers of continuing education for pharmacists. With expanded training in immunizations, medication therapy management, disease prevention, entrepreneurship, and practice enhancement, the *Center for Excellence in Pharmacist Continuing Education* is where OPF will be developing its innovative continuing education that our members have become accustomed to over the years.



Center for Pharmacy Management & Entrepreneurship Training \$300,000

Twenty years ago, there were more than a thousand independent pharmacies in the state of Ohio. Today, there are about 600. We strongly believe that the market is ripe for an expansion of independently-owned pharmacies, with a new



emphasis on wellness and medication therapy management. OPA and OPF have always felt that every pharmacist should have the option to harvest their entrepreneurial spirit, if they so choose, and the *Center for Pharmacy Management & Entrepreneurship Training* aims to offer pharmacy business training, mentor programs, and the education necessary to take over or open a new pharmacy. We intend to assist with the formation of “junior partnerships,” help locate financing, develop a manual that guides pharmacists through the licenses and other requirements, help with selecting business partners, and generally serve as a valuable resource for Ohio’s new and existing entrepreneurs.

Center for Medication Therapy Management Research \$300,000

Pharmacists are now expanding their services to include disease management, advanced drug regimen reviews, administration of immunizations, and many other areas of care. These new and expanded services have proven their worth in improving patient outcomes. Currently, more than 10 percent of hospital admissions are directly related to various problems with prescription medications, and increased pharmacist involvement has been proven to reduce these unnecessary admissions. The *Center for Medication Therapy Management Research* will provide education and certificate programs in various areas of importance to pharmacists. Medication therapy management, pharmacist care development, and disease state management will all be offered by OPE. Programs in the management of diseases and medical issues such as, but not limited to, asthma, hyperlipidemia, anticoagulation, smoking cessation, cardiovascular disease, cholesterol management, and diabetes will be strongly emphasized. Pharmacists practicing in independent pharmacies, hospitals, long-term care facilities, drug information centers, chain pharmacies, and other specialized areas will be offered programming specific for their needs.

Expanded Education and Outreach Centers

Pharmacists Rehabilitation Organization (PRO) Outreach Center \$250,000

One of the unfortunate realities of our profession of handling dangerous medicines is the potential for abuse. Recognizing this, in 1984 OPA co-founded the Pharmacists Rehabilitation Organization, Inc. (PRO) to educate and inform the profession of pharmacy concerning chemical dependency as a treatable disease and to help addicted pharmacists and student pharmacists find recovery from their active disease. The *PRO Outreach Center* will help in expanding the current scope and impact of PRO so that pharmacists can be better equipped to combat prescription drug abuse.

Center for Innovation in Compounding Pharmacy \$250,000

Many patients have unique medical requirements that typical prescription medications cannot meet. Compounding pharmacists fill this important health care gap, and are an integral part of the profession of pharmacy. The *Center for Innovation in Compounding Pharmacy* will embrace and encourage personalized medical solutions based on the timeless art of compounding pharmacy.



Center for Prescription Drug Abuse Awareness \$200,000

Over the last decade, the world has seen an alarming increase in prescription drug abuse, and unfortunately, the State of Ohio is at the front lines of the battle. With accidents and deaths at all-time highs due to prescription



drug abuse, the time to act is now. After having OPA staff and members serve on the Ohio Prescription Drug Abuse Task Force in 2010, it was overwhelmingly apparent that pharmacists need a seat at the table when it comes to finding solutions while protecting the profession. The *Center for Ohio Pharmacy's Center for Prescription Drug Abuse Awareness* features the necessary resources to work with state and local officials to develop programs to fight abuse in Ohio. Action plans, marketing campaigns, pharmacist resources, and best practices for tackling this epidemic will be necessary to keep pharmacists engaged and aware.

Center for Excellence in Medication and Patient Safety \$200,000

With the recent nationwide focus on prescription drug abuse, pharmacists are quickly learning that patients are increasingly taking medication safety for granted. It is important to note that each prescription carries with it potential dangers, side effects, interactions, storage concerns, and lifestyle concerns. Pharmacists are the professional resource to keep patients informed and safe. The *Center for Excellence in Medication and Patient Safety* will offer numerous resources addressing patient safety and the pharmacist's role in public health as a whole. OPA and OPF will aim to create literature, videos, and media alerts to draw attention to this important issue.



Expanded Education and Outreach Centers

Wherry Pharmacy Heritage Museum \$200,000

Pharmacist Paul Wherry graciously donated his entire collection of antique pharmacy items, including various show globes, hundreds of old medications, beautiful glass containers, and many implements used in production of capsules, suppositories, and other items. We plan to display these items proudly, in properly labeled, lighted cabinets. The Museum is a special space where we plan to have seating chairs for small meetings, a video display of descriptions about the collection from Paul and others, about the collection, and a storage area for items to be rotated in and out of the collection on display. Our vision is to have fixtures that are a tribute to this excellent collection, and the man who was a great friend, member, and philanthropist.



Career Services Center \$150,000

The market demand for pharmacists is seemingly changing every single day. Whether someone is a prospective pharmacist, current student, young practitioner, pharmacist seeking a new practice, or pharmacist approaching retirement, the *Career Services Center* will serve as a guiding light for keeping pharmacists educated and prepared for the professional road that lies ahead. Résumé consultations, career coaching, interview training, practice-based education, and recruiting clinics will give interested pharmacists the tools they need to succeed.



Legislative Information Center \$150,000

Advocacy on behalf of pharmacists is what makes OPA one of the most reputable pharmacy organizations in the country. As OPA works to fight key battles on behalf of the pharmacy profession, a *Legislative Information Center* is crucial to keeping pharmacists educated and knowledgeable of issues that impact their day-to-day practice. This Center will help sift through and organize the copious amounts of rules and regulations that pharmacists should be cognizant of in order to provide the highest level of patient care.



Library & Pharmacy Resource Center \$100,000

OPA, through the Public & Professional Relations Committee, established and maintains an educational resource center for member use. In the Resource Center, pharmacists will find various presentations and handouts to help assist them with community outreach or education on various topics. The *Center for Ohio Pharmacy's Library & Pharmacy Resource Center* will house these materials, as well as a wealth of books, manuals, videos, journal archives, and educational guides that pharmacists can use whenever they may need them.

Offices and Gathering Areas

Grand Programming Room \$150,000

One of the key modifications to the existing facility will be the construction of a *Grand Programming Room* that will be used for large meetings, educational programming, training sessions, and live presentations. Built to house up to 60 attendees



at a time, the space will more than double the space offered at our previous location. This room will be reserved for a cornucopia of health care gatherings that will not only serve our pharmacists, but other members of the health care team as well. Pharmacists are integral links in the health care chain – in our *Grand Programming Room*, OPA and OPF will change the philosophy of patient care from pharmacists being invited to the health care table to pharmacists inviting others to the health care table.

Executive Conference Suite \$150,000

Located directly adjacent to our lobby, the *Executive Conference Suite* is the professional board room that pharmacy deserves. The suite will be used for important gatherings, web conferencing, small board and committee meetings, and staff gatherings. With a beautiful, cherry



conference table and board chairs in the center of the room, this executive-level space boasts remote-controlled window shades, a projection screen, an LCD television, a granite-topped mini-bar, and the entire room is custom finished with authentic Finnish carpentry. The *Center for Ohio Pharmacy's Executive Conference Suite* sets the tone for the professionalism of the practice of pharmacy.

Student Rotation Office \$50,000 (Already Claimed)

Over the course of the year, OPA offers an experiential rotation in association management. This rotation gives students a broad view of the profession including federal and state legal and regulatory issues, continuing pharmacy education opportunities, and a venue to network with pharmacists from different practice sites around the state of Ohio. Students leave their month-long rotation with a greater understanding of issues that impact pharmacists, and often become some of the greatest ambassadors for the organization and the profession. The *Student Rotation Office* will give students the tools and equipment they need to succeed during their stay with OPA and OPF.



Offices and Gathering Areas

Member Lounge \$50,000

The *Center for Ohio Pharmacy* boasts a fully-functional kitchen and dining area that is perfect for members to relax and chat over a snack or a cup of coffee. Complete with stainless steel refrigerator, granite countertops, wooden cabinets, dishwasher, LCD television, and dining tables and chairs, the *Member Lounge* is the perfect place for members to network, catch up with old friends, or discuss the latest issues affecting their practices.



Main Lobby \$25,000



The main entrance into the *Center for Ohio Pharmacy* is the first thing visitors see when they enter the building. Featuring a waiting area, receptionist's desk, and coat closet, the *Main Lobby* also features a direct entrance into the famed *Wherry Pharmacy Heritage Museum*.

Technology Room \$25,000

Housing OPA and OPF's main server, copier, printer, and office equipment, the *Technology Room* is the main information hub of the *Center for Ohio Pharmacy*.



Executive Director's Office \$25,000

As statutory agent of OPA and secretary of OPF, the Executive Director represents the organization on behalf of the board. This corner office will be the site of many important meetings for years to come.

Ohio Pharmacy Hall of Fame


