## About the waiver training

Buprenorphine waiver training is available for physicians interested in seeking their waiver to prescribe buprenorphine in the treatment of opioid use disorders. To obtain the waiver to prescribe, providers are required to take eight hours of training.

This is a "Half and Half Training," which means the first half is taken online and the second half is completed in person. The online portion must be completed before the live course on Oct 15. Register <u>here</u> or <u>email</u>. Following the training, physicians who have successfully completed the course may apply to SAMHSA to obtain the waiver. PCSS-MAT urges all physicians who complete the course to submit a Notice of Intent Form (provided at the training) to SAMHSA to obtain your waiver to subscribe.

To be awarded a maximum of 8 AMA PRA Category 1 Credits<sup>™</sup> and a Buprenorphine Training Completion Certificate you must complete 3.75 hours of the first enduring material half and 4.25 hours of the second live half and receive a minimum cumulative score of 75% on the examination.
