Professor of Psychiatry; Director, Yale Depression Research Program

Dr. Sanacora will cover the timely but sometimes controversial topics related to the development and clinical use of ketamine and other putative rapid onset antidepressant medications. The results of several studies examining the efficacy and safety of ketamine and other drugs currently under development for the treatment of depression and mood disorders will be critically reviewed. The discussions will focus on the clinical implications of these novel treatment developments and the potential future impact on the field.

Phil Resnick, MD

Director, Forensic Psychiatry, UH Cleveland Medical Center
Professional, Psychiatry, CWRU School of Medicine

The most upsetting event in a clinician's professional life is likely to be having a patient complete suicide. This presentation will review the latest research on risk factors for suicide in in-patients and out-patients. The faculty will suggest a format for documenting risk factors for suicide, protective factors, reasons to admit a potentially suicidal patient to the hospital, and to not admit a suicidal patient. The session will also cover the implications of suicidal patients perceiving their treating clinicians as adversaries.

Speakers



Colonel Fred Johnson, is the author of the book *Five Wars: A Soldier's Journey to Peace*. Colonel Johnson retired from United States Army in 2014 after 29 years of service with four deployments to include Bosnia, twice to Iraq and once to Afghanistan. He is a graduate of the Army Ranger, Airborne, and Air Assault Schools and he is the recipient of the Bronze Star for Valor and three Bronze Stars for Service. He is the co-founder of *Shakespeare with Veterans*, a program dedicated to helping veterans deal with the challenges transitioning from military service and help them overcome combat trauma and PTSD. He has a B.A. in Government and Sociology from Wofford College and two Masters Degrees. He currently lives in Louisville, Kentucky with his wife Dr. Laura Johnson and daughter Madelyn.



Roger K. Pitman, MD is Director of the PTSD research laboratory at Massachusetts General Hospital and Professor of Psychiatry at Harvard Medical School. He is a graduate of Amherst College and the University of Vermont College of Medicine. He completed his psychiatric training at Tufts New England Medical Center and the Boston VA Hospital. He then served on active duty as a Lieutenant Commander in the U.S. Navy Medical Corps during the Vietnam War. He went on to complete thirty years' service in the Department of Veterans Affairs before moving to Massachusetts General. He has received 20 Federal Government grants as Principal Investigator to study PTSD and has more than 250 peer-reviewed publications in the medical literature. He is a recipient of the International Society for Traumatic Stress Studies' Outstanding Scientific Achievement and Lifetime Achievement Awards.



Gerard Sanacora, MD completed an NIH sponsored Medical Scientist Training Program at the State University New York at Stony Brook, earning his Ph.D. in Physiology and Biophysics in 1992 and his M.D. degree in 1994. He then moved to Yale University where he completed his internship at Yale-New Haven Hospital, the Clinical Neuroscientist Training Program Residency in the Department of Psychiatry, and an NIH funded Neuroimaging Scientist Training Program Fellowship. He is currently an Associate Professor and the Director of the Yale Depression Research Program. Dr. Sanacora's work is concentrated largely on elucidating the pathophysiological mechanisms associated with mood and other neuropsychiatric disorders. Much of his recent research has focused on identifying the contributions of the amino acid neurotransmitter systems (GABA and Glutamate) to the neurobiology of mood disorders and the mechanism of antidepressant action. Specifically, his basic science laboratory employs rodent models to explore the effects of chronic stress on cellular and molecular biology, and examines the molecular, cellular and behavioral effects of novel treatment strategies targeting these affected systems. His clinical laboratory employs novel magnetic resonance spectroscopy methodologies and pharmacological challenge paradigms to identify abnormalities in the function of the amino acid neurotransmitter systems in individuals suffering from mood and anxiety disorders. In addition, he is involved in several early phase clinical trials designed to test the clinical efficacy of newly developed therapeutic agents.



Daniel Nelson, MD is a Child Psychiatrist and clinical professor at Cincinnati Children's Hospital Medical Center (CHMC) where he has directed the inpatient child psychiatric unit for the past 20 years. He's also the Medical Director for the Post Traumatic Healing Center at Children's and has been a founding member of the National Center for School Crisis and Bereavement. He was the administrative supervisor for the initial response at the Oklahoma City bombing at the Family Notification Center. During the 911 crisis he provided consultation to the psychiatric programs at Cornell University in to the Columbia school of journalism. For the next two years he continued to provide consultation to New York City fire department. Dr. Nelson was teaching faculty for psychiatric response in the European masters of disaster program in Novara, Italy. Dr. Nelson has been providing medically assisted treatment after founding the opiate recovery alliance in 2013.



Phillip Resnick, MD is a Professor of Psychiatry and Director, Division of Forensic Psychiatry at Case School of Medicine in Cleveland, Ohio. He served as a consultant in many high profile cases, including those of Jeffrey Dahmer, Susan Smith, Timothy McVeigh, Andrea Yates, Scott Peterson, Casey Anthony, Theodore Kaczynski, the Unabomber, and James Holmes, the Aurora, Colorado Batman movie shooter. Dr. Resnick is a past president of the American Academy of Psychiatry and the Law. He has published over 200 articles and book chapters, is internationally recognized and has lectured in 49 states and 24 countries.

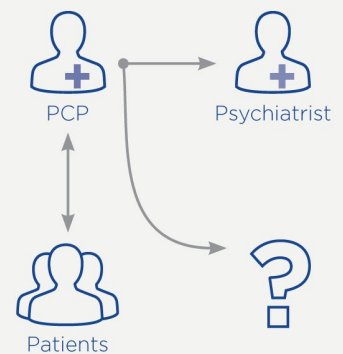

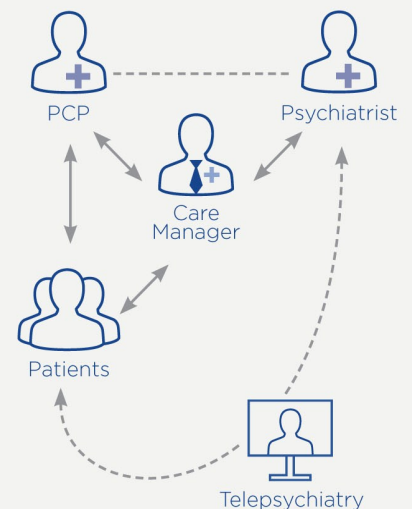
