#### ► HOT TOPICS

#### IRS to phase out paper tax refund checks starting with individual taxpayers

- The Internal Revenue Service, working with the U.S. Department of the Treasury, announced that paper tax refund checks for individual taxpayers will be phased out beginning on Sept. 30, 2025, as required by Executive Order 14247, to the extent permitted by law.
- Executive Order 14247 also applies to payments made to the IRS. Taxpayers should continue to use existing <u>payment options</u> until further notice. Additional guidance and information for filing 2025 taxes will be issued prior to the 2026 filing season.

<u>Treasury, IRS issue guidance listing occupations where workers customarily and regularly receive tips under the One, Big, Beautiful Bill</u>

- The Department of the Treasury and the Internal Revenue Service provided guidance on "no tax on tips" provision. The One, Big, Beautiful Bill proposed regulations identify occupations customarily and regularly receive tips and define "qualified tips" eligible taxpayers may claim as a deduction.
- Treasury and IRS request comments from the public within 30 days to be made through <u>Regulations.gov</u>. Complete instructions on submitting comments can be found in the proposed regulations. Comments on the proposed regulations are **due by Oct. 23**, 2025.

#### IRS assesses \$162 million in penalties over false tax credit claims tied to social media

• The Internal Revenue Service is alerting taxpayers about a growing number of fraudulent tax schemes circulating on social media that promote the misuse of credits such as the Fuel Tax Credit and the Sick and Family Leave Credit.

 The Internal Revenue Service reminds tax professionals that the new form brokers use to furnish statements including proceeds from certain digital asset transactions will be sent to taxpayers in early 2026 but there are steps that can be taken now to help get their clients get ready.

# IRS announces new relief for eligible taxpayers affected by ongoing events in Israel: due dates for eligible returns and payments may be postponed to Sept. 30, 2026; additional relief may be available

• The Internal Revenue Service announced that due to the ongoing conflict in Israel, the agency is providing additional tax relief to affected individuals and businesses, postponing until Sept. 30, 2026, a wide range of deadlines for filing federal returns, making tax payments and performing other time-sensitive tax-related actions.

#### IRS extends relief to farmers and ranchers affected by drought in 49 states, other regions

 The Internal Revenue Service issued guidance that provides tax relief for farmers and ranchers in applicable states and regions who sold or exchanged livestock because of drought conditions.

#### IRS urges emergency preparedness ahead of peak disaster season

 As hurricane season peaks and wildfire risks remain high, the IRS urges individuals and businesses to create or update their emergency preparedness plans as part of National Preparedness Month.

#### Don't forget financial and tax records in emergency preparedness plans

 National Preparedness Month is coming to an end, but that shouldn't limit people from planning for a potential emergency or disaster in the future

#### Ways to help and what to look out for when donating after a disaster

• Disasters can happen anytime, anywhere and everyone should take steps to be prepared for the next potential disaster.
