President's Message

I hope everyone is doing well in the aftermath of the holidays. If you're a student or professor gearing up for the spring semester, I also hope you managed to get some rest and relaxation over the break.

January is an odd time for our organization, as it tends to be a period where our membership numbers drop precipitously. In the past, we have attributed this to the "post conference malaise," where things slow down for a bit in the PCA world.

However, that is not going to be the case this year. The November election has us all pretty riled up, and for good reason. There is a lot of uncertainty related to the incoming administration's plans for healthcare and mental health in particular, and PCA will be working hard in the months and years to come to make sure that counseling remains a viable profession in Pennsylvania.

The latest update: we are in the process of working with our law firm in Harrisburg to draft a practice act for professional counselors in the state of Pennsylvania. A practice act will:

- Provide specific protection for the title of "counselor" in the state of Pennsylvania (i.e., criminal penalties for anyone *identifying* as a counselor without a license, certification or graduate degree in counseling; this is now the case for marriage and family therapists as well as psychologists).
- Provide specific protection for the practice of counseling (i.e., criminal penalties for anyone *practicing* coun-

seling without a license, certification or graduate degree in counseling).

- Provide further safeguards to the public by ensuring that unprofessional or unregulated practices (e.g., conversion therapy) are not offered by counselors.
- Help us to establish greater reputability in Harrisburg during a politically turbulent period.

We will be sending out another round of emails to PCA members, ACA members in PA, and as many students and academics in the state as possible to make sure everyone is aware of what we're working on. I know I can sound a bit like a broken record with this, but once more: we can't keep any of these initiatives going if we don't recruit and maintain new members. It's a shame that progress costs money, but it's something we just can't seem to avoid.

Since I'm already committing to this broken record thing, I should also mention again that we're always looking to recruit new board members! If you have any interest at all in getting involved with PCA as an executive member, I promise I will do everything I can to help you on your way.

I and the rest of the folks at PCA are immensely grateful for your membership and continued support. My very best to all of you in the new year!

President-elect's Message

This has been another busy quarter as president-elect. Most of my attention was in co-chairing the conference committee for the 48th annual fall Conference in November, which was a huge success, boasting the largest turnout yet. I really enjoyed meeting new members and catching up with old friends.

I want to take the opportunity to thank everyone who helped out with the conference, especially our student volunteers. We could not have had such a smooth operation without them.

Believe it or not it is time to be thinking about next year's conference and I am very excited about the energy building around holding the conference in the Philadelphia area. Our hope is to give more members and potential members an opportunity to attend a conference that many could not attend because of the distance to State College. Mark your calendars for the conference in King of Prussia, November 3-5, 2017. Call for Proposals will be going out March 1, 2017.

The Theme for 2017 is one of "Building Alliances", focusing on therapeutic alliances with clients and communities, and also alliances between mental health disciplines. We plan to expand offerings to our colleagues in Psychology, Social Work and Marriage and Family Therapy. Due to the uncertain political landscape, this will be a critical year for mental health advocacy, and we feel that advocacy alliances are going to strengthen that initiative for our members.

As I mentioned in my last update, I am also working on creating a special committee to promote diversity in leadership

in PCA. I am interested in hearing from members that want to work with me on engaging in open conversations about inclusion and representation. I am planning a special meeting during the summer to launch this initiative for the 2017-18 year. There will also be targeted sessions at the fall conference on the topic.

I have also been working with the ad hoc committee on writing a practice act for LPCs that will protect and more clearly define our license and practice. We are making great progress in narrowing down language. We are also proposing the addition of diagnostics as a part of our scope of practice. I have experience with creating this kind of legislation while I was in Missouri, so I feel confident that we will make progress in this legislative session with the dedication of this committee members and our lobbyist.

I am looking forward to representing Pennsylvania and consult with other states at the ACA conference in San Francisco, March 15-19. I encourage all members to try to attend if possible. It is a great experience with incomparable professional development experiences.

It is both an exciting and unpredictable time for counselors, and we need the expertise and support of members to be involved with advocacy efforts, so please contact me if you have any interest in serving on committees or in divisional initiatives. We can accomplish anything if we work together.


