Reports of the Officers and Executive Committee:

- Bishop: 1. Winter/Spring Strategy for Moving into the Future will include LIFT reports. Bishops are still working on the information so some of the reports are not yet available. Vision and Ministry Plan looks at evolving goals of the Synod.
 - 2. Synod Office Holiday Hours. The Synod Office will be closed 12/24/2012 to 01/02/2013.
 - 3. The Bishop and the Synod Staff are currently working with Bob Armstrong of Church Innovations to plan for conversation within the Synod during the new year through the program called "God Sightings in the New Reality".
 - 4. Bp. Holloway reported that as a result of the recent situation involving the unrestricted use of alcohol by some rostered leaders at a youth-oriented confirmation retreat held at a LOMO facility, a number of persons have brought their concerns regarding this matter to him. The Bishop further reported that he personally interviewed approximately eleven persons, both clergy and witnesses. He then communicated with the ELCA attorney and consulted with other appropriate parties concerning issues of discipline which are required to be addressed in accordance with ELCA guidelines. Based upon his research, interviews, and communications with other appropriate parties, Bp. Holloway stated that he responded appropriately with those involved in the situation.
 - 5. The real estate tax issue related to the Synod's building has been successfully resolved. The Synod received a refund check totaling \$111,000 to conclude the matter.
 - 6. Bp. Holloway reported that the Estate of Mary Roese, a former Capital University Professor, left the Synod a bequest of \$4,500.00.
 - 7. Bp. Holloway reported that he will be taking a sabbatical to rest. He will be on sabbatical from November 19, 2012 to

February 21, 2013. During his absence, Bp. Holloway recommends that Pr. Suzanne Darcy Dillahunt be appointed as the Acting Bishop of the Southern Ohio Synod.

- Vice President: 1. Mrs. Klatt thanked everyone in attendance for coming to this special meeting and well as the last meeting. Much was accomplished with a great deal of hard work. The Vice President also thanked everyone for their willingness to make presentations at congregational meetings throughout the Synod regarding the need to be diligent in mission support.
 - 2. Mrs. Klatt reported that she, the Bishop, and the Synod staff met with Bob Armstrong of Church Innovations to create a more specific plan for stewardship. The Staff continued to work on the plan to create time line.
 - 3. Mrs. Klatt reported that she attended a Region 6 Steering Committee meeting. During the meeting, the Churchwide representative berated the Southern Ohio Synod's recent Mission Support percentage of giving to the national church. Mrs. Klatt learned that many synods were visited recently by Churchwide Mission Support representatives but were treated in a much more pastoral and collegial manner. The Vice President stated that the Mission Support percentage policy currently in use by Churchwide simply is not relevant in today's church cultures, and specifically in the church culture evident today in the Southern Ohio Synod. What is the current reality and how do we put those realities in motion? We need to be accountable but we are unique and we are who we are with our own concerns, just as the other synods are unique and they are who they are with their own concerns.
- Gary Pecuch: 1. Mr. Pecuch reported on LYO constitutional issues. The LYO dissolved on churchwide level. The focus now is on recommenndationns for service projects in places such as Charleston WV, Dayton, and Cincinnati. Mr. Pecuch recommends that the Synod Council look at this issue at its January, 2013 meeting.
