Reports of the Officers and Executive Committee:

Vice President:

- 1. Vice President Klatt requested prayers for her family while dealing with ongoing challenges regarding her aging father.
- 2. On December 13, 2013, Vice President Klatt will be in attendance for a Region 6 Steering Committee meeting to be held at Potawatomie Inn at Pokagen State Park near Angola, Indiana.

Secretary:

- 1. Mr. Hart reported that he met with Region 6 Archivist, Jennifer Morehart, on November 11, 2013, to discuss copyright issues.
- 2. Mr. Hart reported that the Synod Council Executive Committee has recommended approval to the Council of a resolution to create a Synod Visioning Team for the purpose of conducting long-range planning for the Synod, and that the resolution will be addressed during the consideration of the En Bloc recommendations later in the meeting.
- 3. Mr. Hart reported that the Synod Council Executive Committee has recommended approval to the Council of a resolution regarding the establishment of 2014 Staff Housing Allowances for Pastor Jeff Wick, Pastor Ed Williams, and for Bishop Suzanne Dillahunt as a component of the overall salary package for each staff member, and that the resolution will be addressed during the consideration of the En Bloc recommendations later in the meeting.

Treasurer:

- 1. Mr. Knilans reported that he received a favorable audit report from Hirth, Norris & Garrison, LLP for the period of February 1, 2013 through August 31, 2013, and that the audit process went well.
- 2. Mr. Knilans further reported that he attended four Fall consultation meetings.
- 3. Mr. Knilans then reported that year-to-date, the Synod's expenses exceed revenues by approximately \$100,000, and that the Synod is approximately \$29,000 below the original Mission Support goal of 40.00% to Churchwide.

Bishop:

- 1. Bishop Dillahunt reported that the Installation on October 26 was great! "Thank-you's" have been sent. Offerings collected during the Installation service totaled \$3,374.25 which will be divided among Capital University, Wittenberg University, Ohio University, University of Cincinnati, Miami University, Jacob's Porch, and Trinity Lutheran Seminary.
- 2. The Fall Consultations among the six conferences have been completed and they went well. The Bishop reported that attendance was up and that more lay leaders attended. One new goal of the Bishop is to restructure the consultation meetings in order to "cross pollinate". She requests that pictures be sent to Susan Barton-Nonno. Bishop Dillahunt reported that five congregations have already returned their goals to the Synod. She requested that each council member take back a "thank you" to each member's congregation.
- 3. Bishop Dillahunt remains hopeful the last quarter Mission Support to the ELCA will increase, at least to meet last year's total. The Bishop encouraged each council member to reiterate the importance of Mission Support to each member's congregation.
- 4. A 25th Anniversary Appeal will be kicked off by the ELCA in February of 2014. The five-year campaign will be a direct solicitation by the ELCA to individual congregations and individual members (if individuals have previously given to Churchwide directly). Each of the 65 synods will piggyback or attach a campaign for its own purposes.
- 5. The Bishop reported that she participated in President Barger's Installation at Trinity Lutheran Seminary on October 27, and that she attended the Trinity Seminary Board Meeting. Her focus is to build bridges with the seminary and looks forward to working with President Barger in the future.

- 6. Bishop Dillahunt attended the recent LSA meeting in Columbus and will be presenting at the upcoming LSSCO board meeting.
- 7. Rev. Dr. Cheryl Peterson, Assistant Professor of Systematic Theology at Trinity Lutheran Seminary, will be the keynote speaker at a rostered leaders event to be held on February 11, 2014. Bishop Dillahunt and Dr. Peterson will be meeting in order to discuss the theme of the event.
- 8. On Saturday, March 15, 2014, the Synod will meet with the Presidents, Vice Presidents, Financial Secretaries, and Treasurers of the synod congregations for a day of gathering and workshops. Synod Council members are encouraged to attend.
- 9. Synod Assembly planning has commenced. The Assembly will convene at Wittenberg University on June 5-7, 2014. The Rostered Leaders Event will take place on June 5, and June 6 is slated as an education day with workshops and worship. Synod legislation is planned for June 7.
- 10. There has been a tradition in the Synod to thank the retired rostered leaders, spouses, and widows/widowers by honoring them at a luncheon. This tradition will continue on December 16, 2013, at a Christmas lunch. In addition and during the luncheon, Pastors Jeff Wick and Ed Williams will be installed as Assistants to the Bishop.
